Qhov Wisconsin Student Assessment System (WSAS) yog ib qho kev xeeb uas siv thooj xeeb Wisconsin uas yuav qhia txog tej kev kawm uas txhua tus tub kawm ntawv paub raws li cov qauv los ntawm Qhov Wisconsin Alternate Kev Soj Ntsuam rau cov tub kawm ntawv xiam hoob qhab (WAA-SwD) yog ib feem ntawm qhov WSAS.

Qhov Wisconsin Knowledge thiab Concepts Examination (WKCE) kev xeeb kuj yog ib feem ntawv qhov WSAS. Yog xav paub ntxiv txog qhov WKCE kev xeeb, thov saib daim ntawv qhia txog kev xeeb qhov WKCE rau Tub Kawm Ntawv/NiamTxiv tom

**Qhov Wisconsin Alternate Kev Soj Ntsuam
rau cov Tub Kawm Ntawv Xiam Hoob Qhab
yog dab tsi?**

Qhov WAA-SwD ntsuas kev kawm ntawm cov tub kawm ntawv uas xiam hoob qhab. Kev ntsuas kev kawm rau cov tub kawm ntawv uas xiam hoob qhab yog los ntawm cov Wisconsin Extended Grade Band Standards qauv uas zoo xws li cov Wisconsin Model Academic Standards qauv. Qhov WAA-SwD kev xeeb rau qeb 3-8 thiab 10 ntsuas kev kawm ntawm kev nyeem ntawv thiab lej. Qeb 4, 8, thiab 10 ntsuas kev kawm science. Txhua yam kev xeeb muaj cov lus nug uas yuav tau xaiv ib lo lus tes. Cov qhab nias rau social studies, language arts, thiab kev sau ntawv yog siv cov qauv uas cov nais khu tau teev tseg raws li cov pov thawj thiab kev soj ntsuam los ntawm qhov WAA-SwD kev xeeb.

Yuav tau cov qhab nias zoo li cas?

Qhov WAA-SwD qhia txog tej kev kawm uas cov tub kawm ntawv paub thiab kawm tau raws li cov qauv los ntawv cov Extended Grade Band Standards. Cov tub kawm ntawv yuav tau qhab nias raws li lawv kev peev xwm. Cov qauv rau kev peev xwm yog tsim los ntawm ib pab tub qhia ntawv thiab cov pej xeeb hauv xeeb Wisconsin.

- **WAA-SwD Advanced (Qib Siab)** – Totaub tob txog kev kawm thiab tej ntsiab lus raws li qeb ntawm kev xeeb qhov WAA-SwD. Tsis yuav kev pab thiab totaub kev kawm thiab cov ntsiab lus raws li cov Extended Grade Band Standards qauv.
- **WAA-SwD Proficient (Txawj txaus)** – Totaub zoo txog kev kawm thiab tej ntsiab lus raws li qeb ntawm kev xeeb qhov WAA-SwD. Tsis yuav kev pab thiab totaub kev kawm thiab cov ntsiab lus raws li cov Extended Grade Band Standards qauv.
- **WAA-SwD Basic (Paub tsim tsawv)** – Totaub me ntsis txog kev kawm thiab tej ntsiab lus raws li qeb ntawm kev xeeb qhov WAA-SwD. Yuav tsum tau kev pab thiaj totaub txog kev kawm thiab tej ntsiab lus raws li cov Extended Grade Band Standards qauv.
- **WAA-SwD Minimal Performance (Paub me me xwb)** – Tsis totaub txog kev kawm thiab tej ntsiab lus raws li qeb ntawm kev xeeb qhov WAA-SwD. Yuav tsum tau kev pab ntau heev thiaj totaub txog kev kawm thiab tej ntsiab lus raws li cov Extended Grade Band Standards qauv.

Yuav siv cov qhab nias ua dab tsi?

Cov qhab nias rau qhov WAA-SwD kev xeeb yuav qhia txog cov tub kawm ntawv txoj kev kawm. Yog yuav kom paub meej, yuav tsum tau ntsuas tej ntaub ntawv uas niaj hnub kawm, lwm yam kev xeeb thiab qhab nias, tej ntaub ntawv uas qab mus ua tom tsev, thiab lwm yam kev kawm. Thov nrog cov nais khu thiab cov counselors tham txog seb yuav siv cov qhab nias ntawm qhov WAA-SwD kev xeeb li cas nrog tsev kawm ntawv thiaj li yuav pab koj tus menyuum caum cuag nws txoj kev kawm. Cov neeg ua dejnum hauv tsev kawm ntawv yuav siv cov qhab nias no los pab kho kev kawm.

- thaug tsoom fwm txoj cai Title I (NCLB) uas yog kev soj ntsuam txog kev kawm ntawm cov tsev kawm ntawv uas yog Title I;
- soj ntsuam xyuas seb cov tsev kawm ntawv twg hauv xeeb ua tau zoo raws li xeeb Wisconsin cov proficiency standards.

Leej twg thiaj yuav tau xeeb thiab xeeb thaum twg?

Kev koom qhov WAA-SwD kev xeeb yog kev txiav txim los ntawm txhua tus tub kawm ntawv cov ntaub ntawv uas yog Individual Education Plan (IEP).
