## PreACT Secure

### New:

#### PreACT Secure Scores

On May 1, PreACT Secure scores began posting to [Success](#). Student scores will continue to post throughout May with all scores and data finalized on May 30. **No paper Individual Student Reports (ISRs) will be sent to schools.** Schools will be responsible for downloading and disseminating ISRs to families. DPI encourages schools to wait until all data is final before downloading and distributing ISRs. Instructions on how to access and download ISRs will be communicated the week of May 27. **Please share this information with your schools.**

## Forward Exam

### Reminders:

#### Forward Exam Reports

The spring 2024 Forward Exam for English Language Arts (ELA) and Mathematics was aligned to the new Wisconsin Standards for ELA (adopted in 2020) and Mathematics (adopted in 2021). Due to this new alignment and subsequent changes to the test designs, Individual Student Reports (ISRs) and summary reports will be available electronically in the DRC INSIGHT Portal July 26. Hard copy ISRs will be mailed to districts August 27. Be sure to send ISRs out to parents/guardians as soon as possible after receipt either in hard copy or via your secure parent portal.

#### Option to Decline Paper ISRs

All districts currently receive the Individual Student Reports (ISRs) in the following formats:

- One master PDF with all students, in all grades, in all schools, in the district (sorted by grade, then school).
- Separate PDFs for each school and grade in the district (multiple files, one for each school and grade)
- New for this year – all districts will receive Individual Student Reports (ISRs) provided in a zipped folder. This format allows for easier upload of the electronic ISRs to a student information system (SIS) or secure parent portal.
- Two paper copies (one for the student file and the other one to be shared with the parent/guardian).

Districts now have the option to decline the paper ISRs by having their DAC complete and submit the [2024 Forward Exam Request to Decline Paper Individual Student Reports \(ISRs\) Form](#) by June 28. Districts are still required to provide parents/guardians with a complete ISR in either a secure electronic version or paper version.

#### District and School Technology Landscape Surveys

Schools and districts that participated in NAEP 2024 assessments should have received an email on Monday, May 6 from [AMS-naep@westatstudies.com](mailto:AMS-naep@westatstudies.com) with a link to a survey that will be used to inform future NAEP assessments. The email was sent to registered District Technology Coordinators and School Technology Coordinators. If those roles had not been previously registered on the [NAEP Assessment Management System \(AMS\)](#), the email was instead sent to the registered District Assessment Coordinator and/or the School Coordinator. Each survey should take about ten minutes; please complete the surveys by May 24.

## Reading Readiness

### New:

#### Diagnostic Literacy Assessment DAC Survey

Act 20 requires DPI to publish a list of recommended diagnostic reading assessments that meet certain criteria. As we work to develop that list, we are interested in the diagnostic reading assessments districts are already using. The Act 20 Diagnostic Reading Assessments survey was sent to all DACs on May 15. Each district is invited to submit their response (one question) about the diagnostic literacy assessments they use in grades 5K through 3 by May 24. #### Reading Readiness Reimbursement 2023-24

District Assessment Coordinators should have submitted the reimbursement request for Reading Readiness for their district by the April 19 deadline. If your district has not yet submitted, please do so as soon as possible. Districts should expect to receive reimbursements by early June.
