

I spoke with Amy Maciolek via phone back in December about a glitch in how Skyward is reporting the immigrant status data as it does not calculate the data correctly. I believe if you look back at the data in WISE you will see Sauk Prairie had been consistently and incorrectly reporting 22 students who qualified as having an immigrant status for the past 10+ years because the data had not been manually sorted and cleaned up. All of the 22 students who had been reported over the years were either foreign exchange students and foreign students who had been adopted by families in the Sauk Prairie District between 2002-2004. None of these students would qualify as having had an immigrant status in the past 3 years. I do not know of a way to go back and resubmit the correct and accurate immigrant status data to you for previous schools years.

In December 2022 I had called you a few times with questions and then again on December 8th with our final immigrant data that was hand calculated and 100% accurate. The numbers from Chanda Kulow, SPSD Curriculum and Instruction Director, this week would have been the data for pupil counts in 2021 and 2022, but the data for 2021 has been lowered as the 3 year mark has been reached by the majority of those students. The data from the email below is as of the pupil count date...what date would you like us to use in giving you numbers? And can the 2022-23 data for the grant include data as of today or just up to the September 2022 Pupil Count date? What can we do to reflect our accurate numbers if WISE cannot be corrected now?

Here is the recap of the data I shared with Chanda via email on December 8th: I wanted to share the updated and correct immigrant status data with you. I also just called and shared it with Amy Maciolek at DPI so she has our correct data as well. I cleaned up the information in Skyward so that it will report to DPI accurately, but am hopeful that Skyward will adjust their calculations for submission so this data can be provided without needing manual manipulation.

Amy had shared that the immigrant status data is taken as of the pupil count each year, so the data below is as of the 3rd Friday in September count date.

As of today (12/8/22)- 41 students (9 foreign exchange students + 32 qualifying students who moved to Sauk Prairie)

September 2022- 33 students (9 foreign exchange students + 24 qualifying students who moved to Sauk Prairie)

September 2021- 22 students (7 foreign exchange students + 15 qualifying students who moved to Sauk Prairie)

September 2020- 15 students (0 foreign exchange students + 15 qualifying students who moved to Sauk Prairie)

Please advise what our next steps should be and let us know the date we should be using to report to you for the grant.
