While reviewing the recipes and observing the day of onsite meal preparation and service there were some inconsistencies with certain recipes: Chicken Caesar Salad (onsite included 2 packets of croutons and a dinner roll), Cheeseburger (remove lettuce/tomato from recipe if not being served and burger preparation method not in directions), Grilled Chicken Sandwich (remove lettuce/tomato if not being served and preparation method of chicken should be specific) and Spicy Chicken Patty on a Bun (method to prepare chicken should be specific). The meal pattern requires a minimum amount of each food component per age/grade group to be offered, regardless of what the student chooses to select. Each line needs to meet the daily meal pattern requirements as well as the weekly meal pattern requirements. Because students are only able to select one entrée option, each entrée option offered is viewed as "one line," and therefore needs to meet the daily as well as the weekly requirements.

Please monitor your school's condiment usage and communicate portion sizes to students, as condiments can be a significant source of calories, saturated fat, and sodium. Promote appropriate serving sizes by adding signage at the condiment stations and/or photos of the planned portion size of the condiments.

According to the USDA Food Buying Guide for Child Nutrition Programs (https://fns.usda.gov/tn/food-buying-guide-for-child-nutrition-programs), one whole, peeled clementine credits as 3/8 cup of fruit. Therefore, two clementine's would need to be offered to credit as 1/2 cup of fruit. Currently, the production record lists 1 clementine as being 1/2 cup of fruit.

The online menu and the production record list several items that were not available to students. Although the menu may change daily the production records should list what is being served daily without the addition of entrees, sides and condiments that were never intended to be served.
