State agencies (SA) are required to conduct administrative reviews to assess School Food Authority (SFA)'s administration of the National School Lunch Program (NSLP), School Breakfast Program (SBP), and other school nutrition programs. The objectives of the Administrative Reviews are to:

Determine whether the SFA meets program regulations,

- Provide technical assistance,
- Secure needed corrective action,
- Assess fiscal action, and when applicable, recover improperly paid funds.

General Program Reminders/Updates:

- The Department of Public Instruction (DPI) School Nutrition Team (SNT) conducts School Nutrition Skills Development Courses (SNSDC) each summer in various locations around the state at no charge. Courses cover many areas of the school nutrition programs including administrative responsibilities, program basics, meal pattern requirements and menu planning, financial management, meal benefit determination process, professional standards, procurement, and many other topics. - SFA staff are encouraged to pursue GOALS Certification. GOALS stands for Goal Oriented
 Achievement Learning Skills. This is a certificate endorsed by the DPI and is obtained by
 completing training in nutrition, program administration and operations, or communications and

Appreciation/Commendations/Noteworthy Initiatives:

Thank you to the staff at Markesan School District for the courtesies extended to us during the on-site review and for being available to answer questions and provide additional information. All were very receptive to recommendations and guidance. In addition, thank you for taking the time to respond to the off-site questions and requests, as well as pulling records for the on-site portion of the review. The files from school nutrition, benefit issuance and district office were all very detailed and presented in an organized manner.

The DPI review team appreciates the eagerness of the staff at Markesan School District for their willingness to make changes to meet or improve school nutrition program regulations. The staff is concerned for the nutritional well-being of their students as evidenced through food safety, menu, service, local wellness, Smart Snacks and obtaining training hours to meet the Professional Standards rule. We were impressed during the lunch meal service at Markesan Middle School that students accepted the variety of vegetables and the fruit offering to select a reimbursable meal. The school nutrition director prepares a complete training folder for cashiers to understand how different menu items count toward the meal pattern and a reimbursable meal within the Offer Versus Serve model.

The School Breakfast Program (SBP) was observed at the Primary School for the youngest students. What a nice way for them to be able to start their day! The staff members there were pleasant and knowledgeable about the breakfast meal pattern. I would encourage you to think about adding a SBP to the upper grades, especially since we ran the numbers to see that all sites except the high school at this time qualifies for the Severe Need Breakfast (SNB) reimbursement.

The DPI review team is confident that Markesan School District will continue to improve their knowledge and operation of child nutrition programs though this Administrative Review.

REVIEW AREAS

1. MEAL ACCESS AND REIMBURSEMENT

Certification and Benefit Issuance

Comments/Technical Assistance (TA)

One hundred seventy-seven (177) eligibility determinations were reviewed, with zero (0) errors
identified. Excellent work by the determining official. She enters the household information into
Power School and double-checks the eligibility status with math calculations before signing the
applications. She will write the income by frequency and not annual as a way to record the correct
information.

Free and Reduced Price Meal Applications

- Applications are reviewed in a timely manner; most completed the same day they are submitted by families. An eligibility determination must be made, the family notified of its status, and the status implemented within 10 operating days of the receipt of the application.
- Children are eligible for free or reduced price meal benefits on the date their eligibility is determined by the Determining Official.

- All free/reduced applications and the direct certification runs were available for review. All
 applications have been correctly approved and students are receiving the benefits they have been
 determined eligible for.
- When an application only has one frequency of payment indicated for all of their reported incomes on the application, the income should not be converted to annual, but using the <u>Income Eligibility</u> <u>Guidelines</u> one would look at the amount of their income under the column indicating that stated frequency (i.e., weekly, twice monthly, every two weeks, monthly, annually).
- When a household has income in addition to a loss from a business, that income must be included on the free and reduced application in full and is not offset by the business loss. A business loss (negative dollar amount) would become \$0 for the income on the application.

Annual Income

• There has been a recent modification to the requirement pertaining to the reporting of annual income on an application. USDA released SP-19, 2017 on March 20, 2017 allowing households to report current income as an annual figure. Annual income is typically reported for households with jobs that are seasonal, self-employed, or agricultural work since that is a more accurate representation of current income. These applications may now be processed at face value. However, most households that receive regular pay checks, will report income based on what is currently earned and the frequency of that pay, i.e. weekly, biweekly, bimonthly or monthly.

Household Size Box

• The total household member size box (Step 3G) includes all children and adults in the household and must match the number of names on the application for that application to be considered complete.

Incomplete Applications

• The determining official is very thorough in contacting applying households who submit an incomplete application (i.e. missing household number box, last four digits of the adult social security number or signature, etc.) They do a great job of documenting the details of the conversation plus date and initials of the determining official.

Application Forms

- If an SFA wishes to change the look or format of the application for Free or Reduced-price school meals or other forms in the application packet, that document needs to be approved by the School Nutrition team at DPI.
- Thank you for using the DPI prototype letters with the current non-discrimination statement.

Other Source Categorical

- If a household submits an application that indicates Other Source Categorical Eligibility, such as
 homeless, migrant, or runaway, the SFA must confirm the children's status by an appropriate program
 official either through direct contact with the agency or by a list of names provided by the agency,
 before meal benefits can be provided. Once confirmed, this eligibility is only available to the
 designated child and is not extended to other members of the household.
- Applications that indicate a child is a foster child are categorically eligible for free meals. The child's status for free meals does not require confirmation of eligibility prior to receiving benefits. This benefit is not extended to other household members.

Public Release

- All SFAs are required to distribute a <u>Public Release</u> before the start of the school year. The purpose is
 to inform the public that free and reduced price meals and free milk are available. Thank you for
 annually distributing the Public Release to:
 - Local news media (Markesan Regional Reporter)
 - Grassroots organizations (food pantry, libraries in Markesan and Mill Pond)
 - Major employers (Del Monte)
 - Local Unemployment Office (as applicable)
- SFAs are not required to pay to have the public release published but must maintain documentation of whom it was sent to along with the specific materials distributed.

Limited English Proficiency (LEP)

- Application materials and other communications with households concerning eligibility
 determinations must be provided in a language that parents or guardians can understand in order to
 diminish any language barriers to participation for individuals with limited English proficiency.
- To assist SFAs in reaching households with limited English proficiency, the SNT provides the Wisconsin version of the USDA Free and Reduced Price Meal application materials in English, Spanish, and Hmong.

Direct Certification

- The effective eligibility date for a DC eligible student is the date of the original output file.
- Thank you for running the Direct Certification matches in the required time frames, when you receive a new student and other times to pick up any newly eligible students.

Transferring Students

- When a child transfers to a new school within the same Local Educational Agency (LEA), the new school must accept the eligibility determination from the child's former school, if the child has an individual eligibility determination.
- Transferring the eligibility determination between LEAs ensures that qualifying students continue to receive school meal benefits as they transition to new schools, and avoids the possibility of unpaid meal charges. FNS strongly encourages LEAs to immediately accept the eligibility determinations made at a student's previous LEA (if they participated in NSLP) when a student transfers between LEAs during the school year, over the summer, or at the start of the next school year. Wisconsin DPI requires source documentation of the student's previous eligibility. The transfer of eligibility between LEAs for students attending CEP schools will be required by July 1, 2019.

Disclosure

 The information provided by the family on the free and reduced price application is to be used only for determining eligibility for meal or milk benefits. This SFA only uses this information for meal benefits!

Verification

Comments/Technical Assistance (TA)

• When applications are chosen for verification, the person designated as the Confirming Official reviews the application(s) to ensure the initial determination is correct prior to contacting the family. The Confirming Official signed and dated the back of the application. The Verifying Official also signed

- and dated the back of the chosen application when the verification process was completed. Nice work!
- Thank you for using the verification forms packet and tracker for the chosen application. The process was handled correctly.
- The LEA has a regulatory obligation to verify "for cause" all approved applications that may be questionable. For more information, refer to the current Eligibility Manual.
- When a benefit eligibility status increases, the change must take place within 3 days. When a benefit eligibility decreases, the change cannot take place before 10 calendar days and a notice of adverse action is sent in writing with appeal rights procedures.

Meal Counting and Claiming

Comments/Technical Assistance (TA)

- Thank you for completing an edit check to calculate your reimbursable meals by site before entering the claim submission. The meal counting and claim for the Review Month was conducted perfectly.
- Meals must be offered to all students each day school is in session a full day, so DPI has created <u>Field</u>
 <u>Trip meal resources</u> to help schools offer student meals (https://dpi.wi.gov/school-nutrition/national-school-lunch-program/menu-planning).
- REMINDER: Meal benefits apply only to the reimbursable meal. The reimbursable meal includes milk as one of the required components, and must be priced as a unit. If the student decides to take only milk, this is not a reimbursable meal and will be charged for the milk as an a la carte item.

2. MEAL PATTERN AND NUTRITIONAL QUALITY from Public Health Nutritionist

Commendations

Thank you for the warm welcome to Markesan Middle School and Primary School. We greatly appreciated your attention to detail and organization. It was a pleasure to work with you all.

Comments/Technical Assistance/Compliance Reminders

Crediting

Proper crediting is an important part of assessing whether or not the meal pattern has been met. The rainbow peppers (red, orange and yellow bell pepper strips) offered during the week of review and day of observation were credited as Red/Orange vegetable. However, because the mix includes yellow bell peppers, the mix actually credits as Other vegetables. There were no vegetable subgroup shortages due to the incorrect crediting, nonetheless, Technical Assistance was still provided on correct crediting of the mix. Alternatively, staff may choose to separate out the different pepper colors (the Food Service Director indicated that her staff mix the tri-colored peppers together in-house) and credit them accordingly (red and orange peppers credit as Red/Orange and yellow peppers credit as Other vegetables). If you choose to just credit the mix as Other vegetable, that is acceptable, too, as the week of review offered plenty of other Red/Orange vegetable options.

Offer vs. Serve (OVS)

Under OVS, students must *select* at least 1/2 cup of fruit, vegetable or a combination as one of their three components in order to claim a reimbursable meal. Even though your staff have had training, it is advised to review OVS regularly.

During lunch service at the Middle School, one student did not serve themselves enough fruit to meet the minimum 1/2 cup serving and reviewers intervened to send the student back. It was unclear if the staff person at the Point of Service would have done so without our prompting. The student did return to the line and select a full, 1/2 cup serving of fruit.

At the primary school, students select their food items and place them into a brown paper bag. The staff person assisting with the service of the food is checking whether or not the student selecting at least three items and that the students has at least a 1/2 cup fruit. All meals were reimbursable. However, best practice would be for the staff person at the Point of Service to look in every student's paper bag and verify three items and at least a 1/2 cup fruit rather than asking the student if they had a "full breakfast" or just how many items they selected.

An <u>Offer vs. Serve webcast</u> is available on our webcast website and additional information can be found in the <u>Offer Versus Serve Guidance manual</u> and is available on our NSLP requirement website found in the Menu Planning tab and under the Offer vs. Serve heading (https://dpi.wi.gov/school-nutrition/national-school-lunch-program/menu-planning#ovs).

Standardized Recipes

The Markesan Middle School Food Service Director (FSD) and staff are doing an excellent job with keeping and using standardized recipes. As a reminder, all standardized recipes must include detailed information about the specific ingredients, equipment, and procedures used to prepare the recipes. This ensures consistent quality and yield every time when the exact procedures, equipment, and ingredients are used, which is crucial for crediting school food service recipes.

The standardized recipe for the Sub Sandwich served on Tuesday 12/12/17 of the week of review listed 1 slice (1oz) Turkey and 2 slices (1oz) Ham under the procedures. However, per the USDA Foods Product Information Sheets, these meats do not credit ounce for ounce. While reviewing the crediting off-site, the reviewer calculated the crediting based on serving 1 oz by weight of each type of meat and the reviewer believed there was a shortage in meat/meat alternate (m/ma). However, after further discussion with the FSD, she indicated that they do weigh the meat slices, and that they serve the serving size as listed on the USDA Foods Product Information Sheets to provide 1 m/ma for turkey and 1 m/ma for ham. The reviewer had the FSD weigh each type of meat in the serving sizes they used to verify crediting and indeed the meat weighed more than what was written on the standardized recipe. One slice turkey weighed 1.43 oz and 2 slices of ham weighed 1.22 oz. In summary, the sub sandwich served **did** meet meal pattern requirements. Technical Assistance was provided on being clear on the standardized recipe on the actual weight that is used (if the product was weighed) so there is no confusion.

Additionally, remember to list all ingredients used in a standardized recipes. The spaghetti noodle recipe served on Thursday 12/14/17 of the week of review indicated to add olive oil in the procedures, but olive oil was not listed in under the ingredients. Please add olive oil to the ingredients section of your standardized recipe. All food items used in the recipe need to be documented in the ingredients section, so that anyone could recreate the same recipe.

4k Students (CACFP)

The updated Child and Adult Care Food Program (CACFP) meal pattern was implemented on October 1, 2017, replacing the previous meal pattern options for SFAs serving infants and children aged 1-5 and not yet in kindergarten. The meal pattern requirements were updated to better align with the Dietary Guidelines for Americans, as required by the Healthy, Hunger-Free Kids Act of 2010. The changes were also based on scientific recommendations from the National Academy of Medicine and stakeholder input. Meals served under the updated CACFP meal pattern include a greater variety of vegetables and fruits, more whole grains, and less added sugar.

It was noted that 4k and K-5 students at Markesan Primary School are co-mingled at breakfast. Therefore, it is acceptable to use the co-mingled flexibility allowing the service of the K-5 meal pattern to both 4K and K-5 students.

If service were to change and the 4k and K-5 students would no longer be co-mingled then the updated CACFP meal pattern would be required for the 4k students. Training

DPI conducts School Nutrition Skills Development Courses (SNSDC) each summer in various locations around the state. Travel and meal expenses are allowable food service expenses and may be reimbursed through the school's nonprofit food service fund. Courses such as Meal Pattern: The Whole Enchilada and Offer versus Serve are recommended for lead workers and menu planners from each site. Information, including dates and locations, will be posted on the DPI training webpage as they are scheduled (http://dpi.wi.gov/school-nutrition/training).

Findings and Corrective Action Needed: Meal Pattern and Nutritional Quality

☐ Finding #1: Due to an unclear standardized recipe for the Deli Sub Sandwich for the week of review (Middle School), it was determined that there was a weekly meat/meat alternate (M/MA) shortage at Lunch (December 11-15, 2017). The standardized recipe listed turkey and ham amounts as 1 oz each, but these meats do not credit ounce for ounce. On site, the reviewer had the FSD weigh the meat slices (1 slice of turkey and 2 slices of ham, as listed on the standardized recipe) and crediting was indeed correct on the recipe, and all entrees do meet daily and weekly meal pattern requirements.

Corrective Action Needed: Submit an updated standardized recipe with the correct ounce weights that were actually used for the turkey and ham. **This corrective action is complete.** Thank you to the FSD for quickly updating the standardized recipe on-site.

3. RESOURCE MANAGEMENT

Nonprofit School Food Service Account

- The Business Manager is aware of the DPI SNT resources for the Annual Financial Report, Child Nutrition Program report and AIDS payments to Fund 50.
- All resource management areas provided complete accountability.

Annual Financial Report (AFR)

- All revenues (reimbursements and student payments) and expenses (including food, labor, equipment, purchased services, and the other category) were separated into each program.
- These numbers could be used to aid the school in calculating its "yearly" reference period for nonprogram food compliance.
- When a student deposits funds in their lunch account which will be used for meal purchases, the amount received is not treated as revenue until the meal has actually been served to the student. The amount of funds on hand in student accounts is treated as a deposit or liability account in either the foodservice fund (Fund 50) or the general fund (Fund 10) until the meal is served, at which point the deposit account is converted to revenue. This amount is not recorded as revenue or part of the fund balance on your Annual Financial Report.

Unpaid Meal Charge Policy

- USDA Policy Memorandum SP 46-2016 requires all SFAs operating federal school meal programs to have a written and clearly communicated policy that addresses unpaid meal charges. Paid Lunch Equity (PLE)

Comments/Technical Assistance (TA)

- Thank you for completing the Paid Lunch Equity tool each year and adhering to the pricing requirements.
- Great job running this tool! The SFA's current weighted average requirement for 2017-18 SY tool is \$2.71.

Revenue from Nonprogram Foods

- Nonprogram foods include: Adult Meals, A la Carte, Extra Entrees, Extra Milk (for cold lunch or milk break), and Food Service operated Vending Machines.
- All costs associated with nonprogram foods, including food, labor, equipment, and purchased services must be covered by revenues received from the sale of those foods. Nonprogram foods may not be supported by reimbursable meals or have a nonprogram foods loss absorbed by the food service account. Thus nonprogram foods may never run in the negative unless non-federal funds are transferred into the food service fund to cover the deficit.
- The USDA Nonprogram Revenue Tool must be completed yearly, at a minimum. The <u>DPI Nonprogram Food Revenue Tool/Calculator</u> located on our website feeds into the USDA tool and aids in calculating prices of nonprogram foods and meeting the USDA nonprogram food regulation (http://dpi.wi.gov/sites/default/files/imce/school-nutrition/xls/non-program-food-

Price-calculator.xlsx).

Adult Meals

 Adult meals are considered non-program foods. Food service programs must price adult meals above the overall cost of the meals.

Total program and nonprogram food costs

- A <u>Wisconsin Adult Meal Pricing Worksheet</u> has been developed to assist the SFA in pricing adult meals (http://dpi.wi.gov/sites/default/files/imce/school-nutrition/doc/wisconsin-adult-meal-pricing-guide.doc).
- Districts need to assess adult meal prices annually prior to contract submission to ensure student reimbursements are not being used to subsidize adult meals. The current reimbursement rates (2017-18 SY) should be used to determine adult prices.

☐ Finding #2: The Nonprogram Foods Revenue Tool has not been completed for the current school year.

4. GENERAL PROGRAM COMPLIANCE

Civil Rights

Comments/Technical Assistance (TA)

 The SFA is mindful of the student population and civil rights to monitor confidentiality in the school nutrition programs.

Nondiscrimination Statement

When including the <u>non-discrimination statement</u> on letters, menus, website, and other documents used to convey program information, it is necessary to use the current statement which was updated in 2015 (http://dpi.wi.gov/school-nutrition/national-school-lunch-program/civil-rights).
 However, when space is very limited, such as on the printed menus or low balance notices, the abbreviated statement may be used, "This institution is an equal opportunity provider." Either of these statements must be in the same size font as the other text in the document.

And Justice for All Poster

• "And Justice for All" posters are posted in public view where the program is offered (each serving area).

Civil Rights Training

- Civil rights training is conducted on a yearly basis for all staff, cashiers and volunteers who administer any portion of a school nutrition program.
- Civil rights training had been attended by all staff in the schools on August 21, 2017 and documentation was available for review.

Civil Rights Self-Compliance Form

The <u>Civil Rights Self-Evaluation Compliance</u> form was correctly completed by October 31 annually.

Special Dietary Needs

- All food substitutions made outside of the meal pattern requirements must be supported by a signed medical statement from a licensed medical professional. SFAs may use the <u>prototype Medical Statement</u> for Special Dietary Needs posted on the DPI website, which is also available in Spanish and Hmong (http://dpi.wi.gov/school-nutrition/national-school-lunch-program/special-dietary-needs). Meals served to students with special dietary needs with the signed medical statement do not need to meet meal pattern requirements. Additional information on <u>special dietary needs</u> can be found on the DPI School Nutrition Team website (http://dpi.wi.gov/school-nutrition/national-school-lunch-program/special-dietary-needs). This <u>flow chart</u> gives guidance on special dietary needs, as well (https://dpi.wi.gov/sites/default/files/imce/school-nutrition/pdf/sdn-flowchart.pdf)
- School food service staff may make food substitutions, at their discretion, to accommodate children
 without a signed medical statement from a licensed medical practitioner. It is highly recommended
 that the SFA have a completed medical statement on file from a medical authority (which could be the
 school nurse) to support the request. These accommodations made for students must meet the USDA
 meal pattern requirements in order for the meals to be reimbursable. It is recommended that the SFA
 develop a policy for handling these types of accommodations to ensure that requests are equitable for
 everyone.
- Juice may not be substituted for fluid milk unless juice is specified as a substitution on a medical statement signed by a licensed medical practitioner. Water is available to all students, but an SFA may choose to offer lactose free milk or provide a fluid milk substitute that meets the nutritional requirements set forth by USDA. Nutrition information for a fluid milk substitute the SFA wishes to provide for students, must be approved by the SNT office. For more information on <u>fluid milk substitutes</u>, please see our Special Dietary Needs webpage (http://dpi.wi.gov/school-nutrition/national-school-lunch-program/special-dietary-needs).
- Fluid milk substitution rules apply to all federal school nutrition programs, including the National School Lunch Program and School Breakfast, but do not apply to the Wisconsin School Day Milk Program. WSDMP allows juice as a milk substitution and is reimbursable. SFAs may offer lactose-free milk to children who have lactose intolerance without requiring DPI pre-approval for use.

Overt Identification

• The meal counting system, MBA Cafe, prevents overt identification of students receiving free and reduced price benefits. Cashiers have been trained on the software system. Thank you.

Processes for complaints

- Schools must have a process for receiving and processing complaints alleging discrimination within
 the school meals program. Markesan School District has board policy #9130 that addresses
 complaints, but should be aware of the different procedures if there would be complaints in the school
 nutrition programs.
- (TA) All SFAs should have procedures (written procedures preferred) in place for handling civil rights complaints in regards to discrimination in the National School Lunch Program and School Breakfast Program. A SFA may always attempt to resolve a situation that is occurring in real time. However, if an individual states that they wish to file a civil rights complaint, the SFA must provide them with the information necessary to do so and not impede an individual's right to file. On-site Monitoring

Comments/Technical Assistance (TA)

- Each SFA with more than one school must perform at least one on-site review of the meal counting
 and claiming system and the readily observable general areas of review identified under 7 CFR
 210.18(h) in each school operating the NSLP and 50% of schools operating the SBP administered by
 the SFA; this is due annually by February 1. These were completed for all sites before I arrived; thanks
 for completing each on separate days.
- The onsite monitoring forms have been updated to include the general areas of review and a new SBP program onsite review form found on our <u>Administrative Review</u> webpage under the SFA onsite monitoring section (http://dpi.wi.gov/school-nutrition/national-school-lunch-program/administrative-review).

Local Wellness Policy

- The local wellness policy requirement was established by the Child Nutrition and Special Supplemental Nutrition Program for Women, Infants, and Children (WIC) Reauthorization Act of 2004 and further strengthened by the Healthy, Hunger-Free Kids Act (HHFKA) of 2010. The final rule requires School Food Authorities (SFAs) to begin developing a revised local school wellness policy during School Year 2016-17 with full compliance of the final rule by June 30, 2017.
- Board policy #8510 was recently modified on December 20, 2017. It includes all of the required components:
- The school district informs the public of upcoming committee meetings, then reports to the school board for updates on the policy implementation. The committee completed the Local Wellness Report Card and provided it to the school board.
 - Specific goals for nutrition promotion and education, physical activity, and other school-based activities that promote student wellness. LEAs are required to review and consider evidence-based strategies in determining these goals.
 - Standards and nutrition guidelines for all foods and beverages sold to students on the school campus during the school day that are consistent with Federal regulations for school meal nutrition standards, and the Smart Snacks in School nutrition standards.
 - Standards for all foods and beverages provided, but not sold, to students during the school day.
 - Plan for measuring policy implementation.

- Designation of one or more officials as being 'in charge' of the policy. Markesan SD named the superintendent.
- An assessment of the policy every three years to determine compliance with the wellness policy, how the wellness policy compares to model policies, and progress made in attaining the goals of the wellness policy. SFAs must make the Triennial Assessment available to the public. In addition, SFAs must make available to the public the wellness policy and any updates to the wellness policy on an annual basis.

Smart Snacks in Schools

Comments/Technical Assistance (TA) from Public Health Nutritionist

• The Smart Snacks Final Rule, published in the Federal Register on July 29, 2016, finalized science-based nutrition guidelines for competitive foods sold on the school campus during the school day. Foods and beverages sold in schools must meet both the general standards and nutrient standards unless the sales qualify for an exemption. You can find more information on our Smart Snacks webpage (https://dpi.wi.gov/school-nutrition/national-school-lunch-program/smart-snacks).

Findings and Corrective Action: Smart Snacks

☐ Finding #3: The following products are non-compliant:

- -Fruit by the Foot fruit puree is not listed as the first ingredient
- -Scooby Doo Fruit Snacks exceeds 35% sugar by weight
- -Oreo Crisps not whole grain-rich

These products need to be discontinued or replaced with another Smart Snacks compliant product.

Corrective Action Needed: Submit a statement how you will bring these into compliance along with your time frame for making corrections.

Professional Standards

Professional Standards: New Food Service Director Hiring Requirements

Comments/Technical Assistance (TA)

• The Professional Standards regulations in 7 CFR 210.30 established hiring standards for new school nutrition program directors, hired on or after July 1, 2015, that manage and operate the National School Lunch and School Breakfast Programs. In addition, the regulations established annual training standards for all school nutrition program directors, managers, and staff which must be tracked.

• Each SFA must designate at least one staff member as a program "director". A program "director" is the person designated to perform or oversee the majority of the program duties such as sanitation, food safety, nutrition and menu planning, food production, procurement, financial management, record keeping, customer service, nutrition education, and general day-to-day program management.

Professional Standards: Training Requirements

- (TA) Annual training must be job-specific and intended to help employees perform their duties well.
 The required annual training hours vary according to the employee's role in the management and
 operation of the school nutrition program. Please include the cashiers' trainings, office staff and
 business manager on your tracking tool.
- Trainings can be provided in a variety of formats (online, in person, webinars) and through various providers (DPI, USDA, in-house, etc.).
- SFAs should clearly document all required training information and maintain that file including the name of staff person, date hired, title/position, brief list of core duties/responsibilities, status (full, part-time, substitute, volunteer, etc.), professional standards position (director, manager or staff). Learning codes are not required, but encouraged. A template tracking tool is posted to our Professional Standards webpage (http://dpi.wi.gov/school-nutrition/training/professional-standards).

Annual Training Requirements for All Staff

Directors: 12 hours

Other Staff (20 hours or more per week): 6 hours Part Time Staff (under 20 hours per week): 4 hours

If hired January 1 or later, only half of the training hours are required during the first school year of employment.

Water

Comments/Technical Assistance (TA)

Water is available at no charge to students during the lunch and breakfast meal services.

Food Safety, Storage and Buy American

Comments/Technical Assistance (TA)

<u>A Flash of Food Safety</u> is a video series designed to help school nutrition professionals understand and apply safe food practices (www.fns.usda.gov/ofs/food-safety-flashes). The <u>Office of Food Safety</u> website (www.fns.usda.gov/ofs/food-safety) includes food safety resources. These may be counted for Professional Standards training hours.

Food Safety Inspections

- Every school operating USDA School Child Nutrition Programs must have two food safety inspections during each school year: including food safety inspection and a review of the site's Food Safety Plan. Thank you for keeping the inspection reports.
- (TA) Food safety inspection reports must be posted in public view

Temperatures

 All cooling equipment must have internal temperatures taken and recorded daily on temperature logs. Posting them directly on the equipment makes recording convenient and a regular part of daily routines.

Food Safety Plans

- The Food Safety Plan was available for review. It was obvious in observing the food service
 manager/director at work that they are very knowledgeable about food safety practices and safe food
 handling. All temperature logs, calibration logs, and sanitizing solution logs were up-to-date.
- The food safety plan must be reviewed annually. The school nutrition staff reviews the food safety plan each year at the back-to-school training.
- Thank you for maintaining a food safety plan which includes all process 1, 2, and 3 items, all applicable standard operating procedures (SOP), all equipment, and food service staff.

Food Employee Reporting Agreements

- (TA) All food service employees must have a signed <u>Food Employee Reporting Agreement</u> on file (https://datcp.wi.gov/Documents/foodemployeereportingagreementsupplement.pdf).
- (TA) Employees must sign a new Food Employee Reporting Agreement form if changes are made to the document. While there are no requirements as to how frequently food service employees must sign a Food Employee Reporting Agreement form, it is the best practice for each food service employee to annually review and sign an agreement to reinforce the information contained in the document.

Time/Temperature Control for Safety (TCS) Food

Milk and dairy products

Shell eggs

Meat (beef, pork, and lamb)

Poultry Fish

Shellfish and crustaceans

Baked potatoes

Heat-treated plant food, such as cooked rice,

beans, and vegetables

Tofu or other soy protein Sprouts and seed sprouts

Sliced melons Cut tomatoes Cut leafy greens

Untreated garlic-and-oil mixtures

Synthetic ingredients, such as textured soy

protein in meat alternatives

Time as Public Health Control

- When using "Time as a Public Health Control:"
 - The internal temperature must be at or below 41 degrees Fahrenheit (°F) at the beginning of the holding period for cold time/temperature control for safety (TCS) food.
 - TCS food can be held up to 6 hours at an internal temperature between 41°F and 70°F under monitored conditions. Provisions must be made to discard product if the 6 hour time limit is exceeded, the temperature of the cold TCS food rises above 70°F, or the food is removed from service.
 - Hot TCS foods can be held up to 4 hours at an internal temperature greater than 70°F. Provisions must be made to discard product if the 4 hour time limit is exceeded, the temperature of the hot TCS food falls to 70°F, or the food is removed from service.
 - There can be no leftovers and no reuse of the items covered under this plan. Thus, if any TCS food is held without mechanical refrigeration during service, including TCS foods on garden bars, all leftover TCS food must be discarded.

Buy American

- The USDA requires that an SFA purchase, to the maximum extent practicable, domestic
 commodities or products. Using food products from local sources supports the local economy,
 small local farmers and provides healthy choices for children in the school meal programs. The Buy
 American provision is required whether food products are purchased by SFAs or entities that are
 purchasing on their behalf.
- The Buy American provision should be included in solicitations, contracts, and product specifications. A reply offer to comply with Buy American terms in a solicitation ensures contractors are aware of Buy American requirements. Furthermore, bidder assurance of the Buy American provision ensures that the bidder is responsive and responsible to the solicitation.
- SFAs must monitor contractor performance as required in 2 CFR Part 200.318(b), formerly in 7 CFR Part 3016.36(b)(2), to ensure that contractors perform in accordance with the terms, conditions, and specifications of their contracts or purchase orders.
- It is expected that the following products will require an exception to Buy American provisions: pineapple, mandarin oranges, olives, tuna, bananas and coffee.
- If no country of origin is identified on the label, than SFA must get certification from the distributor or supplier stating: "We certify that (insert product name) was processed in the U.S. and contains over 51% of its agricultural food component, by weight or volume, from the U.S.," This can accepted within an email.
- What is acceptable to determine compliance on a label? Label should indicate if the product is grown, processed and packed in the continental U.S. and any U.S. Territories. If the label indicates that product is distributed or packed in the U.S, but the country of origin is not listed, this product requires the distributor's certification as mentioned above.
- Any substitution of a non-domestic product for a domestic product (which was originally a part of the RFP), must be approved, in writing, by the food service director, prior to the delivery of the product to the school.
- Any non-domestic product delivered to the school, without the prior, written approval of the Food Service Director, will be rejected. Should non-domestic substitutes that were not pre-approved in writing by the food service director be delivered to and rejected by the school, selected distributor(s) shall be held accountable for all over-claims that result from failure to meet the school's required meal pattern.
- Agricultural products which are processed and produced outside of the U.S. may be accepted with
 proof from the manufacturer that poor market conditions exist (weather, and/or supply availability
 of market); this requirement applies to private labels as well as other labels.
- The SFA should maintain written procedures to ensure the product received and the inventory is compliant with the Buy American procedure. <u>Sample written procurement contract management</u> <u>procedures</u> (https://dpi.wi.gov/school-nutrition/procurement/contract-procedures/contractmanagement) and <u>Buy American monitoring procedures</u> (https://dpi.wi.gov/schoolnutrition/procurement/buy-american/monitoring) are found on the procurement webpage under Buy American.
- There are limited exceptions to the Buy American provision which allow for the purchase of
 products not meeting the "domestic" standard as described above ("non-domestic") in
 circumstances when use of domestic products is truly not practicable. Refer to SP 24-2016 for
 more information on the Buy American provision and limited exceptions.

 - Canned tropical fruit salad (at Primary school) Thailand
 - o Frozen cauliflower (at Primary school) Mexico

Corrective Action Needed: Begin using a Noncompliant Product List for tracking nondomestic products. Provide a copy of the form that will be used and include any noncompliant products currently in the SFAs food storage areas. Provide the completed list as corrective action. A <u>template form</u> is located on the procurement webpage (https://dpi.wi.gov/sites/default/files/imce/school-nutrition/doc/buy-american-noncompliant-list.docx). **COMPLETED ONSITE 1-10-18**

Reporting and Recordkeeping

Comments/Technical Assistance (TA)

- Thank you for completing the required USDA and DPI reports and maintaining the paperwork in an organized manner.
- All free and reduced price applications, including applications from households denied benefits must be kept on file for a minimum of three years after the final claim is submitted for the fiscal year to which they pertain.

School Breakfast Program (SBP) and Summer Food Service Program (SFSP) Outreach

Comments/Technical Assistance (TA)

• At the beginning of the school year, the SFA must notify families of the availability of breakfast and schools should send reminders regarding the availability of the SBP multiple times throughout the school year.

Breakfast Promotion

- Breakfast is offered at the Elementary School only where students select the meal components and put into a bag to eat in the classroom. Promotion is supplied annually through an information packet and promoted monthly on the menus which go to each household.
- Parents play an important role in School Breakfast Program participation. A video was developed
 to help show parents the benefits that the School Breakfast Program provides for them and their
 children. This video along with a brochure can be found on our <u>Resources for the School Breakfast
 Program</u> webpage, in the Marketing Breakfast section (https://dpi.wi.gov/school-nutrition/school-breakfast-program/resources).

5. OTHER FEDERAL PROGRAMS REVIEWS

Wisconsin School Day Milk Program (WSDMP)

- Wisconsin School Day Milk Program requires the distribution of free milk to students eligible for free and reduced priced meals, but only for students in PreK-5th grade.
- Point of Service Counts (POS) for the Wisconsin School Day Program must be recorded by who
 "did" take milk not by marking who "did not" take one. At Markesan Elementary School this is
 completed by the classroom teachers on paper, which is sent to the office for data entry into the
 software, MBA Café.
- The annual claim for school year 2016-17 was verified as correct. Thank you for updating the permanent agreement for this program.
- Per the Agreement for the WSDMP in the points the SFA agrees to, number 3 states that schools will serve Wisconsin-produced milk. This may be a stipulation in the SFA's milk bid.
