Corrective Action History	Finding: The weekly juice limit was exceeded at breakfast. No more than half (50%) of the total fruit offerings may be in the form of juice. The menu as planned was in compliance with the requirements, however two substitutions were made during the week that brought the weekly juice offering over the 50% limit. On Monday, December 12th, orange juice was substituted for raisins. On Friday, December 16th, a Cinnamon Vanilla Blenderless Smoothie was substituted for the cereal bowl. Smoothies with pureed fruits credit as fruit juice and are subject to the applicable juice limitations. A total of 6 cups of fruit (whole fruit and fruit juice) were offered during the week of review, and of that, 3.5 cups were juice. This means 58% of the fruit offered was in the form of juice. This exceeds the 50% juice limit. Corrective Action: Submit a statement that explains what changes will be made to the breakfast menu for the week of review to decrease the amount of juice offered and to be compliant with the weekly juice limit.

Corrective Action History	Finding: During the week of review, Scrambled Eggs were served on Monday, December 12th. A ¼ cup is listed on the production record as the serving size and noted to contribute 2 oz eq M/MA. The CN Label for the pre-cooked scrambled eggs indicate that a 1 oz serving (by weight) provides 1 oz eq M/MA. A picture of ¼ cup of scrambled eggs on the kitchen scale was submitted and indicated that it weighed 1.2 oz, therefore crediting as 1 oz eq M/MA. This does not create a daily or weekly component shortage for the week of review, however does need to be updated on the production records if served again. Corrective Action: Submit a statement that explains if you will plan to change the serving size of the scrambled eggs to contribute 2 oz eq M/MA or if you will update your future production records to indicate 1/4 cup credits as 1 oz eq M/MA.
