The amount of rice that is added to the recipe would held 50, 1 cup servings of rice, not 50, ½ cups of rice.  The Fiesta Chicken Ranch Fajitas (001755) do not credit as obted on the recipe and production record. The serving size of the fajitas is 3.4 oz, noted to credit as 2 oz eq. meat/meat elternate. The recipe includes fajita chicken with a variety of egetables (i.e., corn, onions, green peppers, tomatoes, and halsa). 3.4 oz of fajita chicken alone, without the vegetables redits as 2 oz eq. meat/meat alternate per the USDA roduct Information Sheet. With the addition of vegetables in the portion, there is not 3.4 oz of chicken in one serving as the egetables make up some of the weight. Therefore, this ecipe does not credit as 2.0 oz eq. meat/meat alternate.  The recipies with correct rediting and yield information for the Spanish Rice and iesta Ranch Fajitas.
