Based on Consolidation

The boards of education of the Friess Lake School District, Washington County, Wisconsin (the Friess Lake School District"), and the Richfield Jt. 1 School District, Washington County, Wisconsin (the "Richfield Jt. 1 School District"), acting pursuant to the provisions of §117.17, Wis. Stats., do hereby order that the following school districts be dissolved, to wit: the Friess Lake School District and the Richfield Jt. 1 School District, and that the new school district be created comprising all the territory included in the aforementioned dissolved school districts.

#### It is further ordered:

- 1. The name of the new school district will be Holy Hill Area School District as provided in §115.01(5), Wis. Stats.
- 2. The type of school district structure will be Common under §115.01(3) and will operate under this provision of Chapter 120, Subchapter 1.
- 3. The grades to be taught in the newly created school district will be Pre-Kindergarten through Grade 8, under §115.01(2), Wis. Stats.
- 4. The school board of the newly created school district will be composed of seven members, under §120.01, Wis. Stats.
- 5. Pursuant to s. 120.02(3), Wis. Stats., the method of election and the terms of the initial members of the consolidated school district board of the newly created school district shall be as follows:
  - a. There will be five seats that will be at large in accordance with §120.06, Wis. Stats. The highest vote getter for the at-large seat shall be awarded a three (3) year term. The second highest vote getter for the at-large seat shall be awarded a three (3) year term. The third highest vote getter for the at-large seat shall be awarded a two (2) year term. The fourth highest vote getter for the at-large seat shall be awarded a two (2) year term. The fifth highest vote getter for the at-large seat shall be awarded a one (1) year term.
  - b. There will be one seat that will represent the area of Friess Lake. The area of Friess Lake is defined to be the boundaries of parts of the Village of Richfield and Town of Erin as delineated on the attached map. The highest vote getter for the Friess Lake area shall be awarded a one (1) year term.
  - c. There will be one seat that will represent the area of Richfield. The area of Richfield is defined to be the boundaries and properties of the portions of the Village of Richfield and Town of Erin as identified on the district boundary map. The highest vote getter for the Richfield area shall be awarded a one (1) year term.
- 6. The date of election of the first school board of the newly created school district will be the 3rd day of April, 2018, under §117.22(2)(b), Wis. Stats.
- 7. The time and place of the first annual meeting, if one is held, of the newly created district will be 6:00 pm on October 22, 2018 in the Friess Lake School Library, Hubertus, Wisconsin in accordance

with §117.17(1), Wis. Stats. The secretary of the board shall give notice of the first annual meeting under §120.08 (1) (c), Wis. Stats. and shall designate a person to act as temporary chairperson of the annual meeting until a chairperson is elected.

8. The effective date of this reorganization will be the 1st day of July, 2018, in accordance with § 117.08(2), Wis. Stats.






