Palmyra/Eagle Dissolution

To Whom It May Concern,

I am a current resident of Palmyra, WI. I have not attended the schools, nor do I have any children that have attended schools in this district. I state that so you understand my viewpoints are not based on emotion in any way.

Here are what I believe to be the facts:

- 1. The majority of the residents in Eagle believe the Mukwonago School District offers their children a better educational opportunity and do so while being better, more responsible, stewards of the taxpayer money. The DPI information about school performance would support those residents' viewpoints.
- 2. The enrollment trend downward in general from Palmyra/Eagle speaks to either problems within the school district, better options in surrounding communities, or both.
- 3. The open enrolling of Eagle students to Mukwonago will continue if the school district is not dissolved. Palmyra/Eagle school district does not have an answer to this problem.
- 4. The Palmyra/Eagle school district is hemorrhaging money and has been accumulating debt at a disturbing rate. The school district does not seem to be able to solve its financial problems, except by requesting more money from the taxpayers via referendum. In the April referendum, the school district attempted to first pass language that would have had the tax increase continue forever. When the voting public saw that, they voiced their clear disapproval and the school district scrambled to change the referendum language to a 4 year tax increase, not indefinitely. (See point 5 below regarding how that went.) The FACT is the school district has no solution for solving their financial problems except for referendum money. The referendum they proposed, which was more than the voters could stomach or afford, would have only kept the school doors open for the next 4 years. Referendum money does NOT solve the school's financial problems, it merely kicks the can down the road for 4 years until they have to come back again for another referendum.
- 5. The tax referendum of April of 2019 was clearly portrayed by the school district as a "do or die" scenario. They were CLEAR that if the referendum was not passed the school district would have to dissolve. The communities also were very clear when they voted against the referendum by a 61-39% margin (a landslide by the current political standards in this state.) Anyone who would claim they didn't understand dissolving was the only option if the referendum did not pass did not read any information about the vote, or are outright lying.
- 6. The November non-binding referendum regarding dissolving showed a second time that a majority of the voters support dissolving the district. 53% of the voters supported dissolving.

Those are the facts. Here are some of my own educated opinions.

Some people will point to the closer vote outcome in the November non-binding as a sign that people don't want the school to closer. For the April referendum, the total votes cast were 3,749. For the November non-binding,

the vote total was 2,298. That is a 38-39% decrease in voter turnout between the 2 elections. The November non-binding was initiated by a individual against dissolving and backed by the teachers' union. This referendum attempted to be hidden as the only item on the ballot so the anti-dissolving crowd could rally their troops. I only found out there was a referendum on the November ballot by seeing a sign in a yard in Eagle about 2 weeks before the election. Once the cat was out of the bag, both sides attempted to rally their support. It is my opinion that the non-binding results skewed more favorably towards the opposition to dissolving due to the power of the school district, teachers union, and extra time they had to inform their supporters of the referendum. I believe if the referendum had been properly advertised to all voters and had other important elections on the ballot, the 6% margin would have grown larger, although not to the 22% margin of the April referendum.

The side opposed to dissolving only have an emotion argument. Parents will get up to speak or parade their children up there to plead with you to not close their school. Alumni of Palmyra/Eagle will get up there and talk about how great their experiences were and plead for it not to dissolve. Teachers and staff may plead too. This is not an emotional decision. I hope you on this Board can understand that. It is a financial decision.

According to the Daily Union newspaper website, enrollment has dropped more than 35% since 2007. Let that sink in. In a little over a decade, these schools have lost over a third of their students.

A plan of any kind that splits the district, allowing Eagle to go to Mukwonago, and Palmyra stay open as its own school district does not work. The school Board President said so himself. Palmyra, as a community, cannot sustain its own school district, nor can it absorb its portion of the debt racked up by the district over the past years.

If you need to play the blame game, here is what I think are the causes:

The school administration and Board have not cut costs equal to the decrease in enrollment over the past decade.

The school administration and Board have not found ways to improve performance or provide incentives to discourage open enrollment out of the district.

(The prior 2 points may not just apply to the current administration and school Board, but would likely apply to previous people in those roles as well.)

The majority of the current school Board are too personally vested in being beholden to the teachers/staff and having children in the school district to really be able to make hard, necessary cuts.

Jefferson County does not help the situation by making decisions that prohibit growth of their population and tax base.

I was discouraged and angered to see the form you are using at your public hearings. There are boxes people can check to express why they are there (in favor of dissolving or not in favor of dissolving, to name a couple options.) When questioned why that form had options like that, your representatives said it was to ensure the opinion of the community was being accurately represented. Why would your public hearings better represent the feelings of the community over the 3 votes passed just this year? I would remind all of you of the following.

- 1. The voting public overwhelmingly voted against the April referendum when clearly faced with the choice to give the school more money or dissolve the school district.
- 2. The school Board themselves voted to dissolve based on the results of the April referendum.
- 3. The voting public again showed their stance in the November non-binding referendum by voting to dissolve.

If you on this Board consider the pleas at your public hearings to be the accurate voice of the communities and not the 2 actual referendums we have had, then what you are doing is a partisan farce. The communities have

spoken not once, but twice. The school Board has voted to dissolve. It is your job to help the surrounding communities determine the best way to assimilate the Palmyra/Eagle students, in the best way possible for those students and families. It is not your job to decide it is in the best interest of the students to keep this failing school district open and ignore the 2 votes by the actual taxpayers of these communities.

I will not be providing my personal information as part of a public record as I believe my viewpoints will put me in the cross-hairs of an over-emotional and unscrupulous opposition to dissolving that are not afraid to harm those with whom they disagree. If it is necessary for me to validate my opinions or residency by providing my personal information, then I would welcome a solution that does not include my information being part of the public record.

#### To Whom it May Concern;

I am a resident in the Town of Eagle within the Palmyra-Eagle School District. I realize that these are criteria you will be taking into consideration regarding the decision to dissolve Palmyra-Eagle School District if applicable:

- (1) The geographical and topographical characteristics of the affected school districts, including the estimated travel time to and from school for pupils in the school districts.
- (2) The educational needs of all of the children residing in the affected school districts, the educational programs currently offered by each affected school district and the ability and commitment of each school district to meet those needs and continue to offer those educational programs.
- (3) If territory is proposed to be detached from one school district and attached to an adjoining school district or proposed to be included in a new school district under s. 117.105, whether the proposed detachment will have any adverse effect on the program currently offered by the school district from which the territory is proposed to be detached, including both curricular and extracurricular aspects of that program.
- (4) The testimony of and written statements filed by the residents of the affected school districts.
- (5) The estimated fiscal effect of the proposed reorganization on the affected school districts, including the effect of the apportionment of assets and liabilities.
  - (6) Whether the proposed reorganization will make any part of a school district's territory noncontinuous.
  - (7) The socioeconomic level and racial composition of the pupils who reside or will reside in territory proposed to be detached from one school district and attached to an adjoining school district, in territory proposed to be included in a new school district under s. 117.105 or in school districts proposed to be consolidated or in a school district proposed to be dissolved; the proportion of the pupils who reside in such territory who are children at risk, as defined under s. 118.153 (1) (a); and the effect that the pupils described in this paragraph will have on the present and future socioeconomic level and racial composition of the affected school districts and on the proportion of the affected school districts' enrollments that will be children at risk.
  - (8) The results of any referendum held under s. 117.10.

To be honest...Items 1-3, 5-7 have been addressed by the 279 Eagle students that have open enrolled out of Palmyra-Eagle School District. 217 of these students are already being educated in the Mukwonago school district that is closer and able to provide a better education to them. Mukwonago and Whitewater have been proactive to make sure they have their residents covered and possible Palmyra-Eagle School District students will be taken care of by researching and coming up with plans to incorporate Palmyra-Eagle School District if dissolved.

Item 4 seems to be what needs to be looked at for our situation. This is not about annexing (which a large portion of Eagle in the Palmyra-Eagle School District has already tried) this is about if the community wishes to dissolve or save Palmyra-Eagle School District. I can tell you that over 75% of the residents of Eagle have

refused to pay for any referendum that this district asks for. We are tired of the "arrogant holier than thou bully mentality" of the District staff, administration, and school board (past and present).

This is NOT a new problem that just occurred due to open enrollment, this has been an issue for over 13+ years. Over 13 years ago, it was brought forth that the district did not have a single dollar budgeted for building repairs. They spent everything they had and felt that residents would just have to pay when they needed it. Referendum after referendum have failed. The Administration and School Boards have refused to make changes to account for declining enrollment. Instead of consolidating schools, they cut educational programs and teachers and yet increased upper admin staff with higher salaries. Dear SDBAB,

My name is \_\_\_\_\_\_, and I have been a student in the Palmyra-Eagle school district since I moved here in the 5th grade. Starting at a new school wasn't a forign concept to me. I had moved to the Jefferson school district shortly after my parents divorce. I repeated kindergarten and stayed until the 4th grade. While at Jefferson I witnessed, and was subject to, bullying and the poor management of children with behavioural issues. Once I moved to Palmyra in the third grade I was given the choice to open enroll back to Jefferson, which I did. As the year continued, I began to naturally make friends with kids on my street and they told me all about their school. That's when I realized that the elementary school I was attending acted more as a breeding ground for bullies than as a safe learning environment. Once I finally made the switch in the 5th grade I was walking into the unknown once again, but once I arrived on the first day everyone welcomed me with open arms. I had never felt such a strong sense of belonging in my life, however this was also around the same time that my life as I knew it would change forever.

Half way through the 5th grade year I began to have issues focusing at school, at first I thought it was nothing until my teacher and my mom started to talk to me about all the missing work I had and my grades. As a 5th grader I didn't really take all of it in and just blew it off, until the principal, Steve Greenquest, got involved. From that point on, I was in the office almost every day so he could personally check to see if I got my homework done. This also carried over into my 6th grade year. At the time I thought it was ridiculous that he was doing this. I felt like it wasn't fair that I was the only one subjected to this, however looking back at it I see how much he truly cared about how I and every other student did regardless of what grade level they were at. It blows me away to see that level of care put out by a teacher, much less a principal, who will most likely be a faded memory in most kids minds by the time they're in high school or college. While going through this my dad was admitted into the hospital for unknown reasons and only after a few days was rushed to the ICU while I was visiting him. The school was notified of what I was going through and handled it in the best way possible, making me feel like I wasn't alone and could talk to anyone. The one person I confided in the most was my 5th grade teacher, John Knoot. He was the first person to welcome me to Palmyra and became one of the biggest role models I think I will ever have. Not only did he help me in the classroom, but he helped me with all of the issues I was having outside of school. We would sit and talk in his classroom after school often times for an hour to an hour and a half but sometimes it went ever longer. Even after going into 6th grade I would still visit him on the regular and talk about issues, I considered him to be more than a teacher but a friend by the time I entered middle school. 6th grade was the worst year of my life; I couldn't stay focused, I would butt heads with the teacher and the principal, and I had given up on school all together. But the one thing that made this school year the worst one I ever had, was my dad. At the start of the 6th grade year my dad had been in the hospital for about 8 months, having just received a transplant and being discharged from the hospital into a rehabilitation center. My entire family was hopeful, until the last week of September when my dad was admitted into the ICU for what would become the final time. On Saturday, October 4, 2014, at 5:10 p.m. my father passed away after 9 long months of battling his illness and almost beating it. When it came time for the funeral, my entire family was shocked to see that my principal, my 6th grade teacher, Tammy Anderson, and Mr.Knoot, were

all in attendance at a funeral that took place in the middle of the day during the week. The next week I returned to school once again feeling that warm welcoming feeling I received when I was a new student except it was different, when I came into class and opened up my desk I saw at least a dozen or so cards from all the kids in my class and even kids not in my class, and it was an emotional experience for everyone to witness. Later on that year my family set up a fundraiser for the high school golf team in memory of my dad, we raised of 300 dollars for the high school golf team which at the time didn't have team golf bags. I was also invited to come practice with the high school team as a 6th grader and this happened on more than one occasion.

The start of the 7th grade year was more of the same regarding focusing issues, fortunately this issue was solved at the beginning of the 3rd quarter I was diagnosed with Attention Deficit Disorder as well as Depression, and PTSD and was swiftly medicated for them, this saw a massive jump in grades that shocked the middle school staff and school administrators. After that problem was solved I was able to go from an F and D student to an A and B student within about a week or two, and after that I haven't looked back.

My freshman year saw tragedy strike again, my mother was admitted to the hospital and eventually diagnosed with stage 4 renal failure and the first to come and support me and my mom was the school. My sophomore y I joined the football team and I've never felt more at home than I did playing for the Palmyra-Eagle Panther football team, even though it was my first year ever playing football the coaches were patient and supportive of me playing and pushed me to be the best that I could be and taught me lots of life lessons.

I feel like I know more about the referendum and the school than most students at this point in time and I think I have a high enough intelligence to speak about how this will affect the state and the town. First of all the most if not all the businesses in town rely on the school as a means of business weather it be the students or the families that reside in the town, without a school people will leave slowing killing local businesses hurting the local economy on a larger scale, most of the people in town work for two of the large companies in the area, Generac and Standard process, these two companies would most likely take a hit due to the amount of people leaving and having to find new jobs for convenience sake. This combined with the hit that land value would take in the area many homes won't sell and will go abandon or sell for dirt cheap due to there not being a school nearby. I understand that groups have talked with the governor and have protested in the capital about our situation and I personally don't think it would look good if governor Evers let the only school in state history close especially when he has been fairly quiet in regards to doing anything politics wise.

Now as a junior with an unknown fate in front of me all I can do is think back to the days where I was just a number in a tactile system of big city education, and I fear for my classmates who may have to go and endure that system, a system where they won't play varsity or play at all, a system where you won't always get the help you need due to the class size, a system that is often times too big or too ignorant to notice when bullying is going on and believe if your the kid whose school closed your going to be bullied. I know what it's like in the bigger schools and I don't think most of these kids will be able to handle how that system of education works much less being separated from everyone you know and grew up with. The one thing I want you to take away from this unorganized, rambling mess of an email is that big doesn't always mean better and please don't forget about the little guys and that breaking apart such a cohesive group of staff and students would do more than kill the town it will leave an everlasting scar on the Wisconsin state government and psychological damage to those who were forcefully ripped away from what love the most.

Dear School District Boundary Appeal Board,

I am writing to you as an employee of Palmyra-Eagle Area School District. This is my 13th school year working in the PEMS/HS Main Office as an Administrative Assistant. When I was first hired at PEASD, I was unfamiliar with PEASD. I had three children attending Mukwonago Area School District, where my husband was a graduate as well, and I attended West Allis Central High School and Holy Assumption Catholic Grade School. Therefore, a district the size of PEASD was completely unfamiliar to me.

Upon being hired, I had friends in the Mukwonago district ask me why I would want to work for such a poor district. Many said they had heard negative things about PEASD, and they would never send their kids there. When I asked them for details, they could never give me any. They just would say that "they heard." The people that said those things were open enrolled into Mukwonago from PEASD and admittedly never even stepped foot into a PEASD school. Most moved into their homes with the intention of never sending their kids to PEASD and just open enrolled right from the beginning without ever checking out the PEASD school district.

As my time working for PEASD began, I was completely blown away by how wrong all of those people were about PEASD school district. I could not believe the differences I was learning between the large schools that I was accustomed to and the small school that I was now spending every day observing.

The main differences that I observed right from the get go were the closeness of the students, staff, and parents. Everyone really does know everyone. I, myself, very quickly learned each student's name, knew their parents by the sound of their voices, and learned of each student's family dynamics. This makes for a very nurturing learning environment for each and every student, much like the parochial elementary school I attended while growing up.

Next, I had heard a rumor of bullying at PEASD, but the difference was bullying was not near as much of a problem as PEASD as it is at larger schools. Bullying is handled promptly, simply because you hear of issues as soon as they happen at a small school, and the administrators know each student personally, so nothing gets by in a small school. At Mukwonago, I was personally involved in a very serious bullying situation with my own son that went on for three years. I had to jump through major hoops to get someone to listen to us and get involved. At PEASD, I have personally observed any mention of bullying being promptly handled immediately, without question. Bullying is everywhere, the difference is how it is dealt with, and from my experience, I believe smaller schools deal with it more promptly and efficiently.

Sure, Mukwonago offers more AP classes, more sports, more clubs, etc., but they CAN. They have more students and more money to do so. PEASD offers as much as they possibly can with the resources they have. If all of the open enrollment money stayed in the PEASD district, they could offer more as well. However, PEASD offers enough. Enough to educate their students to get accepted at major universities such as UW-Madison and succeed just as much as any student from a larger district. Just as in any other school, students get out of education what they put into it.

Yes, their test scores may be a little lower than some neighboring districts, but there again, it is the money. From personal experience, I know that the larger districts are preparing students better to do well on the standardized tests, preparing them better for ACT tests, and providing better preparation needed to perform well on those tests. I believe PEASD could do that as well if they had more money for the resources

to do so. However, I have seen the success of PEASD graduates when they meet up with the other students in college. It sometimes may take them a semester to catch up, but the majority catch up very quickly, so how important are those tests to the future success of their students, not very. The ones who complete all of the AP courses offered at PEHS also have the option to take more college courses at UW-Whitewater, which is very close.

I believe Mukwonago does not need anymore students from outside of their district. The high school finally has the room it needs. My two older children went there with over-crowded hallways, and my youngest was able to attend one year with the new larger building. The middle school is already bursting at the seams. There are new subdivisions and apartment buildings being built in Mukwonago district currently that are going to add even more students very soon. I have many friends in Mukwonago district, and they do not want to take on students from outside the district. They feel their school is big enough. They would be upset to learn that their school district is attempting to take over half of PEASD students. The majority of MASD parents have no idea that this is even in the works. MASD parents were not given a chance to vote for if they wanted to take on students from outside of their district. I believe that if MASD is given the Waukesha County half of PEASD, there will be future problems with overcrowding at MASD. I can foresee the parents there being very upset if their children have to be shifted from one elementary to another or whatever changes would come with acquiring half of PEASD.

The sports are a major reason that some students open enroll to larger schools as well. They falsely believe that they will have better recognition on a sport at a larger school. However, that is not usually the case. Unless your student is a stand-out athlete, your student will see less actual participation on a sport in a larger school, and they will be lucky to make the team at the varsity level. At a school the size of PEASD, all students can be on the team, and most get a good amount of participation time. Actually, they have more recognition than they would in a large school as it is easier to make it to State, and talented athletes stand out more in a pool of fewer athletes. And participation is what sports should all be about any way, not sitting on the bench watching.

It has been difficult for me to hear the group of people who are open enrolled out of PEASD bad mouth PEASD district and turn Mukwonago into a dirty word. Mukwonago is an excellent large district and my children did very well there. But the actual families of Mukwonago district (not the open enrolled ones) do not view PEASD as competition. They understand that there is a major size difference between the two, and they are not on the same playing field. The people who bad mouth PEASD are people who open enroll out of PEASD and do not actually live in MASD. Those people most likely paid less for their houses than they would have if they had been in the MASD district, and it is an easy way to raise their property values by becoming MASD residents. Many are seeing this as an opportunity to raise their property value and also decrease their taxes. However. they do not understand that if all of their tax dollars went to PEASD, PEASD would also be a stronger district. And many just believe bigger is better, and they want free busing for their students. But, then they should have purchased a home in MASD in the first place. This is a situation where open enrollment has gotten out of control. It is a group of parents who want what they don't have and their bullying and bad mouthing of PEASD has gotten way out of hand. They constantly make up false rumors about PEASD and put it on social media and spread false information, which are slowly ruining the way people (who do not know any better) see PEASD. For instance, the one that PEASD never cut any staff when they started to endure financial troubles, which I can tell you first hand, is untrue. When I was hired, there was another full-time secretary working alongside me in the main office, and that position was cut approximately five years ago, along with many others.

PEASD is a diamond in the rough, so to speak. They are an excellent district that could be so much more if they had the financial resources. However, they do very well with what they have, but unfortunately, it is not enough to keep their head above water these days with state funding being the way it is. I believe that there should be a line drawn through Eagle, and MASD should be given students who are closer to Mukwonago so that it helps to alleviate the open enrollment issues that PEASD faces, since unfortunately, I do not see the open enrollment option going away any time soon. I also believe that one of the two elementary buildings needs to close and the sixth grade needs to be moved into the MS/HS building as there is room for them there. I feel like PEASD could stay afloat with fewer students and less expenses. If we cut loose the children that

school choice out on the one end of Eagle, I believe it will actually make PEASD stronger, because less space will be needed to educate students, and the bad mouthing/false rumor spreading will stop by those people. The area is growing, and I believe there will soon be more of a need for PEASD schools as Mukwonago grows bigger and more people move west. It will happen, and PEASD will be needed even more when it does, but if PEASD dissolves, it will be too late.

- As a valedictorian, I felt I did not have to work very hard to achieve this status. I am not super smart by any means, as I did not achieve a stellar score on my ACT. There were also 6 valedictorians, and one of them took only the very basic classes/ no AP classes/ only gym classes senior year and still achieved the "valedictorian" status.
- I took every AP class, besides AP calculus, that my school offered. I only benefited from my AP psychology class because the other classes I did not do well enough on the AP exams. I think this was partially to blame on my teachers. We were not prepared to take the AP exams. When I started college, many of my friends received many credits from their AP classes, and passing their AP exams was a common thing. However, at Palmyra Eagle, it was not a common thing to pass these exams.
- There was a lack of class options. There were only a handful of AP classes and not many elective classes offered. I would have liked more class options to prepare for my future better and take classes I actually enjoyed. As someone who wanted to go into more of the medical field, I felt there were no classes to expose me to this. Other schools like Mukwonago are able to offer these opportunities to students.

#### Athletics

- Sports teams were not very competitive
- There were no cuts to any sports.
- So many of our high school sports teams were coached by a player's dad contributing to favoritism. Everyone knows how that usually goes.... In life, your mom and dad are not always going to be there to give you everything you want.
- You also can't get rid of every coach you don't like. So many of our coaches had been "run out" of the town by parents that did not like the coaching style or the playing time their child received. This teaches kids absolutely nothing except when you don't like your coach, just get rid of them. I feel that at a bigger school, this would not be tolerated. Unless there are legitimate reasons for a coach to be fired, kids need to learn that they might not always like who is in charge of them and learn to adapt.

- When I was in 8th grade, the high school basketball coach was known to be doing inappropriate things with his players and students. The high school athletic director was fully aware of this, as the basketball coach lived in his basement, and did nothing about it.
- I felt I had a close relationship with my teachers and had very small class sizes, however I sometimes felt like teachers were not the most professional in the way they interacted with students.

#### Social Life

- Growing up with the same group of friends my entire life felt like the only option. Diversity is not something PEASD offers to students.
- Everyone is up in each other's business.

In conclusion, I believe the best thing for students of the PEASD district is for it to dissolve. I now see how much more is available in other districts and PEASD just cannot compete.

Excerpts from my November 7th verbal testimony to the SDBAB against dissolution:

Twenty three years ago, my husband and I moved our family from Northern Illinois to Southeastern Wisconsin because of a job offer. Having a 3 year old and a 6 year old at the time, our first and foremost priority was schools. We researched which school districts were located within a reasonable driving distance from where my husband would be working. We toured schools, talked to teachers, administrators, and other parents that had students in those districts. We chose Palmyra-Eagle. Soon after that decision we searched for a home within district boundaries, found one in the town of Eagle, and moved in the day before our 6 year old started first grade. We've been here since, our children are 29 and 26 respectively, and we have never regretted the decision to raise them going to P-E.

Did we choose this district because we thought it was perfect? Absolutely not. All districts have their strengths and their weaknesses, but we believed then and still do now that the strengths of Palmyra-Eagle are core to what we were looking for. A small, rural district with unique opportunities and offerings because of those two factors.

The weaknesses we saw, we worked to change. Be the change you want to see happen. That, I believe, is a great lesson to teach your kids, as well as other adults. Volunteering in the classrooms, serving in the PTO, participating in fundraisers all help to create positive change within schools. Wanting to take the opportunity for change even further I ran for the school board. I was elected and had the privilege to serve this community in that capacity for seven years, three as board president, and saw firsthand some really awesome things that were accomplished by positive people working together to better the educational experience for all of our students.

I know, because of that experience, that proposing change in schools can be difficult. It takes hard work, tough choices and decisions that aren't always popular. I am not asking that the Palmyra Eagle Area School District remain the same, or go back to how it operated when I was on the board. I recognize and understand the major financial challenges here and that things will need to look much differently in our future. Looking differently is better than dissolving and not having a future. Things happen, good and bad in all aspects of life. Challenges arise, you don't quit, you work to fix things. Perhaps we'll need to close a building or two, or revisit the request to allow a large portion of Eagle, including the Eagle Elementary building, to detach from our district and become a part of the Mukwonago district.

School districts are not the buildings they use to operate within. School districts provide the heart for what takes place inside those buildings. The structures within our district don't matter, our students do. Whatever the new look of P-E needs to be, please allow us to remain and to continue to provide the small rural option that many families seek, and that many children need.

My final point is this; there was no community input solicited, that I am aware of, before our voters were presented with the plan to remain status quo for four years, or dissolve.

Referendum informational meetings were set up, yes, but informational meetings are not an opportunity for collaborative efforts to hear and actually consider ideas outside the box that may indeed have merit. Myself and many other community members would like the opportunity to propose a strategic plan that may require major changes, but changes that could be positive, unique and make Palmyra-Eagle a district that families choose to come into, rather than opt out of. Please give us the chance to try.

I want to close with something shared with me by a co-worker who saw it posted on social media. He told me it was from a long time educator in the Fort Atkinson district that is recently retired. She now subs in other districts, including Palmyra-Eagle. She saw the video that our PE students made and shared it on her page, along with this comment: "I've had a chance to meet some of these (Palmyra-Eagle) kiddos when I subbed there. I have to say the thing that really impressed me was how kind they were to each other in the halls. Do you know how rare that is? I really hope they can keep their school. They love it!"

Dear members of the SDBAB,

My name is Katie Tucker and I am a village of Eagle resident. I have three children who currently attend Eagle Elementary, with my oldest being in 6th grade this year. I am in favor of finding a solution to keeping a school in my community.

When my oldest started school in Eagle in 2012, each grade section had two classes. As she progressed through the grades, I saw enrollment decline to the point that there was just one class per grade level. I was perplexed as to what was happening, as I had no problems whatsoever with the school or my daughter's education. She is exceptionally smart, and the teachers did a wonderful job educating her. One of the things I love about Eagle is the smaller class sizes and the one-on-one attention they get. Everyone knows each other, and the principal knows all the students and parents by name. We really feel like we are part of something unique and special.

My daughter was looking forward to being in middle school at PEASD next year, and eventually joining the dance team in high school. She saw these opportunities as possibilities in a smaller school, but is concerned what her experience will look like in high school if she is forced to attend Mukwonago – where there are upwards of 400 kids in a class and each student is merely a number.

We have come to really appreciate a small, rural school district, and see the many positives of attending a smaller school. I always assumed my children would attend the school in the community where we live, and I never considered any other district. It saddens me that people choose to build a home or move to Eagle because the cost of homes here is less than in Mukwonago (as are the taxes) – yet they never step a foot in our schools, and decide that they will just open enroll out because the Mukwonago schools were always their first choice and Eagle is close enough to the district they wanted. This has killed PEASD financially!

It devastates me to think that the PEASD buildings may close and become empty or bulldozed. What kind of community will Eagle or Palmyra become, with no schools? Will families want to even live here if there are no local schools? (especially Palmyra?) I find it ironic that there are "active adult condos" being built less than a half mile from Eagle Elementary. This village will become a senior living community without any open or operating schools here.

This issue has torn apart a community. The people I once thought were my friends and neighbors are being nasty to each other on social media. Adults are acting like children. No one wants to come to an agreement, and each side is equally emotional about the topic. I am not sure why enrollment has decreased so much at PEASD. Those that have not had good experiences go around bad-mouthing the school district, spreading opinions claiming to be facts, and will stop at nothing until the school district goes away. For my family and my kids, this is just extremely sad, because we love the school district, and Eagle Elementary holds a special place in our hearts.

I am not ignorant to the fact that PEASD has financial issues. Open enrollment is one thing that has severely hurt PEASD, but I also believe that more cuts can be made to make the district operate with a sounder budget, especially if one or more buildings or jobs/positions are consolidated. A committee can be started to see what families in this area want out of a school district and education, and steps can be taken to make that happen. The school can be even better than it was before (which is already pretty great by the opinion of so many!)

It does seem that the majority of Eagle wants out of PEASD. If that's the case, let them go. But *please* keep Eagle Elementary open and operating, even if it's with another school district. So many great teachers are there, and it is in a great location, next to the Eagle Nature Trail. The school is kept up very well with many nice updates. It's a wonderful asset to the community, and what an absolute shame it would be to see it go away. Another big concern of mine is that Mukwonago schools are already over-crowded as they are. Does Mukwonago even have room for all the kids that would come from Eagle? How long would it be before they would have to expand their schools and go to referendum to pay for it?

I would love to see Palmyra keep a school district going. I feel worse for them in this considering Whitewater schools (or any school district for that matter) are so much further away. What a detriment to Palmyra to not have any schools in the community, and I can't imagine the effect it would have on the businesses there. We may even choose to move to Palmyra and attend the school district there if it remains open.

I hope the SDBAB will be reasonable in finding a solution that will benefit the communities and our children. **Bigger does not mean better!** Our kids and families should have a choice to attend the small, rural schools vs. the massive school districts. I fear for all the small school districts in Wisconsin eventually being swallowed up by the big ones. No school district is perfect, and there is room for improvement at all schools. There are enough people who support PEASD and believe in it—this should not be ignored.

Thank you for your participation on this board and hearing all the facts before making your decision. I know you are considering what is in the best interest of the children. I hope that what will come out of this will make our community schools even better than before and will make the fight amongst neighbors come to an end.

I am writing to you again as I am appalled at comments that were made at the Thursday night meeting in Eagle. I have heard rumors about Eagle residents spreading lies. Rumors of how mean and nasty they are. I had no clue if these rumors were true, or just how bad they were.

Wow, I must admit how shocked I was to hear some of the things that I heard that night. There were so many blatant lies made by those who oppose keeping OUR district open. I think the school does an amazing job in educating our students regarding bullying and the consequences if bullying is to occur.

Thursday night I heard comments regarding the special education department at PEASD. Those who are for the dissolution of our district had nothing good to say about the Special Education Department, the teachers, or aides. I have no idea where they are getting this information from or what they are basing it on. The Palmyra-Eagle Special Education Department is amazing. Literally no child gets left behind.

My daughter has been a part of the special Education Department since she was in 4th grade. She struggled terribly in math. Life at my home was terrible. She suffered from low self esteem. We tried to help her with her homework. It usually ended up in a major argument. Life was miserable for all of us. It was draining and depressing.

Once she got tested and began getting help from the Special Education Department our world changed. Our household was happy and light again. We did not have to walk around on egg shells. She walks the halls with pride and self confidence now. She has made the honor roll every semester since middle school. Now as a Sophomore she is excelling in all of her classes and has great relationships with her teachers.

The special education department has a group of outstanding people working for them. EVERY single class, all day long has an special education aide or teacher sitting in on it. They are learning what is being taught and are available to be hands on right there in the moment. They are also able to help out students during their 9th hour

study hall or their 4th hour resource class. I really don't know what more the Special Education Department could do to improve their program. They are doing fantastic work. My daughters grades are proof of that.

Quite possibly the most absurd thing that I heard that night was people accusing PEASD supporters of criminal activity. Slashing of tires and felony acts committed against them. It is one thing to challenge how our school system runs or how we have used past referendum money. To down right lie about physical "attacks" shows lack of good character in my view. To whom it may concern,

I am in favor of registering in favor of dissolving the Palmyra-Eagle School District.

I live in the Town of Eagle, Waukesha County, WI. I'm a middle-aged citizen and have two high school students that we chose to school-choice to East Troy. That said, I also have a great interest in our future generations of children in this community. I have seen the mismanagement of PEASD over the past several years, both financially, and academically.

I see the performance of PEASD lagging behind that of both East Troy (ETASD) and Mukwonago (MASD) area School Districts. My choice is for the Eagle children south of Hwy LO to attend the ETASD. The division of the rest of PEASD would benefit from some of the neighboring districts.

Now examine the financial side of it, especially for those of us struggling to make ends meet. ETASD taxes are lower than what PEASD has stated they need to survive, yet their academic numbers are better it simply isn't feasible, reasonable, or sustainable.

Over 40% of Eagle parents have Open Enrolled their children to other districts. You MUST ask yourselves why? As a parent who chose to open enroll out it was twofold. We had raised our kids in the ETASD and moved to Eagle. We chose to keep the kids with their friends for the duration of their education. The second reason for open enrolling was due to the mismanagement of the budget in the last several years.

I've spoken to many people in both the Town and Village of Eagle. In the Eagle community, we seem to identify with either East Troy or Mukwonago as a community rather than Palmyra. As a matter of fact, we don't even travel to Palmyra because our jobs take us through Mukwonago. All of our shopping and social issues are based around East Troy and Mukwonago, not Palmyra. Why would we want to continue to have a School District that has no other community ties to us except the School itself? This District was only established in 1974, not a very long time in the big scale of things.

Now through mismanagement PEASD is in terrible debt, with no end in sight to stop the hemorrhaging of money. There have been multiple referendums in recent years and the communities have answered the call time and time again to stop with the tax increases. Had the school district properly budgeted and addressed the problems at hand, we likely would have a different conversation at hand. Even with massive tax increases, there is no guarantee the problem will be solved.

Subject: Dissolution of PEASD

Hello,

My name is Erika Schwane. I live in the Village of Eagle and I am in favor of dissolving the Palmyra-Eagle Area School District (PEASD).

Thank you for your time evaluating PEASD.

I want to provide some background prior to providing my opinion and testimony. I moved to Eagle 2 years ago. I have 2 children (4 & 5 years) and 2 step children (9 & 15). My children have or will be open-enrolled into Mukwonago Area School District (MASD) and my step-children who reside primarily with their mother in Palmyra, are in PEASD. The father of all 4 children who happens to be a graduate of PEASD and resides with me in Eagle is in favor of dissolving the district and supports the decision to open-enroll our children together out of the district. Obviously, this situation has caused tension in our family.

When we moved to Eagle, despite having children in the district, we had NO IDEA that there were financial difficulties in the district nor that we would be blind-sighted by dissolution. The district does however have a reputation of being one of the worst in the area and the DPI report cards and my experience seem to match the reputation. This gave me concern, but I thought I would give it a try and enrolled my son in 4K at Eagle Elementary last year.

Prior to moving here, I had observed the 9 & 15 year old in attending PEASD for several years. One of my step-daughters is special needs requiring an IEP and was not provided the resources she needs to thrive in the school. What I learned very quickly is that the school simply does not have enough teachers or special ed programming to enrich a student needing more support - that child ends up being labeled as a nuisance, pushed aside and to the parent to correct, and then bullied. I experienced this again when my son attended 4K at Eagle Elementary last year. He is a normal, active boy with a love for school. He has been in a daycare center environment since infancy and is well-versed in following schedules in a school-like setting. However, throughout the year last year I received communications from the teacher that he was disruptive, having difficulties learning, and unable to follow directions. This was perplexing considering I had never received the feedback before. I offered to help in the classroom to observe and what I saw was a teacher who was overwhelmed and having difficulty maintaining a classroom of young learners.

When the referendum information came out last year, it started to beg the question, what kind of talent are they attracting? Is this why my son is struggling? In addition, my 2 step-daughters have been victims of constant bullying that the school has done nothing to resolve. Several cases so bad that the police were involved and the eldest child switched elementary schools form Eagle to Palmyra in hopes of a fresh start. Why is this happening in a school that has such low class sizes and is described as a welcoming rural district??

When it came time to decide on the referendum, the decision was clear, especially after some research. PEASD has had financial problems for years, they have an awful reputation in the area that proved true in my experience, and the factors working against them (funding, open-enrollment, population decline, and their reputation) are insurmountable. In addition, why would I as a parent want to increase my tax money to send my children to a school where DPI report cards are seriously lacking compared to the neighboring districts? With this referendum, they could only pay to maintain the buildings (which are in a sad state), and they've already

made so many cuts that the school is operating a bare minimum with hardly any after school or enrichment programs. Plus, it feels they hid all of this from the community. I strongly believe that PEASD is in a position where they do not have enough resources for the kids they have despite the small class sizes they tote, especially those that are special needs or troubled. I've seen it first hand - kids are suffering.

This year my son has had zero issues. He left 4K at Eagle Elementary behind on his letters and numbers, with no plan put in place all year to help him resolve it. Now he is 5K at Prairie View in MASD and thriving. At his most recent conference, the teacher told me he is a model student with a passion for school and that he is right where she would expect after some specialized learning identified when he entered 5K after his time in Eagle. This was a complete 180 from his conferences at Eagle Elementary where he was a distracted troublemaker. I couldn't believe it. In that moment, I knew my decision to open-enroll was the best decision I could have made for my son. And next year, when my daughter starts 4K, she will attend MASD as well, whether through open-enrollment or dissolution. Our kids deserve to love school, have the support they need to thrive, opportunities to explore clubs, and attend school in buildings that are in good working order in a district that is transparent and fiscally responsible ensuring their success. They deserve more than the bare minimum. The world is a competitive place and learning needs to be top-notch and agile in order for our kids to survive in life and work in the future.

I am not willing to let my kids be a guinea pig to PEASD while they try to correct the problems they have either caused, ignored, or fell victim to. At this point, it is beyond repair. It is sad to see a district dissolve but the realities in this situation make it the best option for the community, it is inevitable.

Subject: Yes for dissolution

I've been a resident of the village of Eagle for 26 years. I've raised 3 children. 2 of my children have Cognitive disabilities. My husband and I tried to work with the schools with our first. The walls we hit and dealt with K-12 were many. No one wanted to be accountable to actually carry out an IEP Plan. If we had ideas they were shot down. We were told the district can't do that, can't afford that. Teachers stating they were unaware of the IEP. Bullying was another wall. A high level MS-HS official stated we let him fall through the cracks, we should have done better. At his Junior year IEP meeting the Director of Pupil Services opened the meeting stating the IEP would be closed out because he was cured, no longer needed any help. We fought that and won. Disabilities can't be cured. He was doing well because of the mandates of the IEP. You take those away and he wouldn't do well. He ended up in a GED program through Madison College. His last semester he was pulled out because the PEASD said they needed the space and money for others. They made an Austistic Learning disabled child finish his online course work in a small office next to the principal. A child who learns better with a teacher and much interaction. The other program was with 6-8 students and a moderator/teacher. He barely made it by to graduate. Due to the blatant disregard in their duty to educate any type of child we chose to OE our daughter to Mukwonago for HS. She did well there despite being Intellectually Disable (10-12year old level). She had options never mentioned or available for her brother. These two have overcome the poor educational system only because they have parents who questioned and advocated for them. They have faired far better with postHS programs that I found. Transition was nonexistent at PEASD.

Our 2nd child is a good student. He didn't want to leave PEASD for Mukwonago. He's doing well, but really could be doing much better. In elementary school I brought up to teachers that he was capable of completing his brothers homework. 2 grade levels above him. Asked to be tested and was told no. But other children were able too. Why not mine? One child who was able to test ahead was the son of a school board member. He's a good student because he works for it, what else could he have accomplished if he was given the opportunity. Mediocrity isn't all right.

I work in the community as an Emergency Department Nurse. I see so much wrong and troubling with the students from PEASD. Bullying issues not dealt with and leading to substance abuse and Suicidal behavior. I have worked with some recent graduates of PEASD and they're unhappy on multiple levels. The one that strikes the most is they feel that they were unprepared for post HS life. Critical thinking skills and study skills are lacking.

The School Board here at PEASD has not been truthful, has not been forthcoming with information and has not been proactive for the student population and the community. The mismanagement of funds and educational content needs to end. The votes are in, twice. The voters said no to more money. The voters said yes to dissolution. With the school board openly stating there are no other options.

The emotional blackmail by current students is appalling. No child is going to say YES to such a change.

Grant the dissolution of PEASD. Let the community do what they have already stated they want as evidenced by the votes. It seems like a no brainer for Eagle to join Mukwonago. Better education for less tax, and it's what the majority says they want.
