### Dear Committee,

We are writing to humbly request a detachment, or small territory transfer, from the Waukesha County school district to the Elmbrook school district for our address of 19325 Rivendell Dr., Brookfield, Wi 53045 and its neighboring homes. As you can see in the attached maps below, the district line unnecessarily and disproportionately divides our neighborhood down the middle of our street (Map 1). The few houses south of this line are excluded from the local community at large (Map 2). We therefore propose a very small, easily implemented change where northeast corner of the district line would be moved slightly south into the nature conservancy, alleviating this neighborhood division and preventing future concerns.

As my wife and I both work at Froedtert hospital, the current districting places an additional and unnecessary burden for us to get our kids to school when other public schools are much more easily accessible to our address. According to Google Maps, the distance from our home to Hillcrest Elementary is 4.0 miles southwest (opposite direction to Froedtert Hospital), whereas Brookfield Elementary is only 1.7 miles northeast. Similarly, Horning Middle School is 4.4 miles southwest, whereas Wisconsin Hills Middle School is 1.1mi southeast, and North High School is 9.3 miles southwest, whereas Brookfield Central High School is only 2.0 miles northeast.

While we were aware of the school districting prior to buying our home, we were not aware of the neighborhood division, nor its impact on local community events around school districting. Since we moved a little over 1 year ago, our girls have made friends with our neighbors across the street, and we have noticed that the Elmbrook school bus passes through our neighborhood. We would love for our kids to attend school with their neighbors across the street, and to be able to take the school bus that passes by our house already.

While open enrollment remains a theoretical option, we are told spaces are limited, that there is no guarantee of acceptance. Furthermore, there is a long wait list, and there have been no openings for a long time.












Map 3. Parcel and lot numbers of the relevant homes. The red line denotes the current school district boundary.

Secretary Sue Ettinger read the notice of hearing as follows:

He announced that the only information presented hereafter would be requested by school board members concerning the information received by them or brought out at this meeting. Board discussion included review of the arguments presented, the facts/recommendations presented by the administration, and the impact of this detachment on the Waukesha School District.

### Motion:

President Como indicated that the alternative decisions are a motion to deny the request for transfer of the territory described in the petition; or a motion to grant the request for transfer of the territory described in the petition.

W. Baumgart moved approval to deny the request for transfer of the territories as listed in the petition identified as The Shire. That the reorganization requested in the attached petition filed on January 13, 2022 to detach territories described in said petition from the School District of Waukesha and to attach to the School District of Elmbrook be denied on the grounds specified in sect. 117.15, Wisconsin Statutes, and further that said petitions be dismissed. Seconded by J. Como.

President Como explained that the vote would be conducted by ballot and confirmed that a yes vote means the detachment is not supported.

Ballots were collected; S. Ettinger announced vote on motion: The detachment request is denied. Vote was 7-0.

President Como noted that procedure requires a motion to adopt a resolution authorizing issuance of an order.

W. Baumgart moved to adopt a resolution authorizing the issuance of an order of denial. Seconded by G. Deets. Motion carried 7-0 by roll call vote.

Thank you. Following the rules, my name is Ritch Durheim um uh I am my address is 19405 Rivendell Drive in the Shire subdivision. I have been a resident of the Shire for seven years um built our house

Any other, what were some of the other requirements? before I uh I get the name, address, email just in the school district of...oh yeah, the school district, um I think as well as the others that are here tonight are all part concurrently part of the um Waukesha segment that was shown on the um uh on the screen the blue green um so um just some other facts you may know but they're I think they're relevant to some of the issues it's um for Brookfield because we're in in the town of you know the village of the city of Brookfield for taxes and other things like that for we are relatively small um in terms of number of residences in our subdivision 33 and I believe Max uh effect uh in the uh in the school district eight even I mean no it's so I thought it was I was counting houses on the way out but I uh maybe over counted anyway the reason that's important is as part of what we're um you know a big part of what is driving this petition um when my wife and I were retired moved in um seven years ago into our new house I would say the subdivision was maybe 50 or 60 percent so you know 60 65 percent built out and um we found the um people didn't really know each other and like I said there were fewer even than are now we're full now for the full 33.

So um and what we have found I would've, I've observed in that um in that seven years of being there um that um it used to be just people who were either with grown children or you know like us and um no not too many um were in student or students in school at this point in time, I think there were there were some but very few relative to the number of houses today seven years later there are many that see the buses and um and they uh out there playing and whatever um in the seven years that I said the new houses have been built and others have moved in and so the situation is much different and um we being 33 people were at close knit um you know the proxy the physical proximity or topography as you see up there or saw before is relatively small. There's the lower level and then it circles up to the to the uh and so again we're um everybody knows everybody else it's um the kids play together they were there in some sports together and um to me and they don't even understand why like where I can't get on that bus or do whatever you know or things like that so um but I think in the end it's we moved to suburban communities to have just that community and while we have our annual um party um in the end you know we're divided we're divided by um these kids go to a and these kids go to b and the more in the majority go because there's more houses 24 other houses are going one way and then there's those that are not going to the up to the same um to the same school district. So um I'll let max you know show the map and do others other things but to me um like i said we one of our uh one of our president's here who's on the board with me there I'm, by the way I'm the president of the HOA, forgot to mention that. and um our efforts we have a small three-person board uh one of them, Sarah over there is there is one of them and we strive for community um you know we've had you know um uh parties you know and we have another one coming up in September and uh this year you know through our dues we bought everybody us you know from the board you know and we and we continue to grow as a community and this uh right wrong or different it's um it would it would be so much better if we had all you know that

together and that's one of the reasons and um a major reason why I'm supporting this very strongly so and you know I whether I know you um Joe was it? Yes, Joe. Joe you know kind of rattled off the statutory issues and I know that fiscal um at least I get the sense from talking to people that the fiscal impact on the affected the affected district may be an issue. I don't know all the numbers but it's hard to have to uh it's hard for me to imagine that eight houses out of I don't know how many houses are in the Waukesha School District but how the impact the fiscal impact of um losing eight houses to the Elmbrook um could be that significant, but like I said I don't have the numbers um so with that um I have no other comments.

Any questions?

President Como: Thank you, Rich. We will have a chance to so. What we'll do I guess yeah is there any questions for what Rich presented because we will have a chance to come back and ask more questions too so we'll have sure uh each of you present um and then we'll hear from the opponents and then we'll be able to have again some questions in some dialogue.

Ritch Durheim: Okay well then thank you very much I appreciate that.

President Como: Thank you, Rich and I think the only other person that uh we had signed up was Max but again more people can talk. Okay thank you Max you want to come forward?

Welcome Max.

### Max Krucoff:

Thank you.

All right hi everyone I'm Max Krukov. I live at 19325 Rivendell Drive in Brookfield. I'm part of the Waukesha School District and I'm one of the houses that's proposing the detachment so first of all, I just want to say a sincere thank you to the board for meeting and hearing us out. I recognize this is a complicated issue and so I just wanted to say thanks for the time. So you guys saw a picture of this earlier but this just to give you a sense uh this is the School District and this label here is my house and my wife Kate's home and then if you zoom in you can see the borders so the red area here is the Waukesha School District and the non-labeled side is the Elmbrook School District and we live on Rivendell Drive and the border goes right down the middle of our street so that's kind of the essence of the petition and our humble request. So this is a zoomed in version of our neighborhood and here you can see Rivendell Drive is right here um and this is a picture of Rivendell Drive and this is our home. So you can see the families and the kids literally right across the street from us go to Elmbrook and these eight homes are in the Waukesha School District and what we didn't realize we moved into our home we had no moral opposition to being in the Waukesha School District, it's just we didn't realize that the kids across the street went to a different public school and our kids have basically made friends with the other kids in the neighborhood and the Elmbrook buses literally drive down our streets and how we're going to explain that about a three-year-old and a one-year-old daughter um how we're going to explain that

and why they can't get on that bus is a pretty tough one just starting from sort of a logical perspective.

So this is a little bit more zoomed out okay so these are our homes here this is the at the north east edge of the school district and you can see right behind us is a big nature conservancy so it's all forest and the line comes up and it just grabs these eight homes and you can see how these eight homes and our neighborhood are just all physically connected up here and there's no if you sort of zoom out and look at why these eight homes are kind of grabbed from this physical connection. There's no kind of logical reason other than probably historical lines before the settlement was built or the subdivision was built and then if you zoom out even further it's even more striking so basically the line comes up and grabs a bunch of forest and then just these eight homes and so that's all we're requesting is just that this sort of last little piece of the subdivision be allowed to join the school district which we are physically connected to.

You know Brookfield Central is right there and you know Brookfield Elementary is right here and the other piece of this is a large part of the motivation is both my wife and I are physicians at Froedtert and uh every minute we have to see our kids is precious it's not easy and a commute to the Waukesha schools is in the opposite direction and depending on elementary, middle, high school is either two to three times as long in the opposite direction so the reality of us being able to actually take our kids to and from school uh is far less than if we were to be districted into the schools to which we have much closer proximity and would be on the way to Froedtert so that's the motivation behind the request. The distances to the schools um are in the petition and the changes if you look at map number six as an example there's a google map from our home to Waukesha North High School is 9.3 miles and it's 15 minutes west whereas the commute to Brookfield Central High School is 2.1 miles and five minutes east so it's literally three times as long in the opposite direction. Having said that I know there have been cases made about the potential for open enrollment uh into the local schools without a detachment. That was the first thing we looked into I have included as an attachment a correspondence from the Elmbrook group about the potential for open enrollment and they've basically said there's been no open spots for six years and the chances of actually being able to enroll our kids through open enrollment is virtually zero. So I've attached that correspondence and those are the highlights so the big, just to sort of summarize, the big thing is the line right down the middle of our street the buses to the Elmbrook schools come right down our street; our kids have made friends with the people in our community so we're hoping that you guys will see that the driving distance is just an objective barrier to our quality of life, the opportunity for open enrollment where it may have been realistic some time ago sounds like it's probably not a realistic option anymore, and the potential for my wife and I to make time with our kids on the way to and from school and potentially take them ourselves would not be, is likely not possible with commutes to Waukesha schools where it likely might be to Elmbrook. So, with that I'll conclude and take any questions this time.

President Como: Okay Max, thank you and we did have a third person, Cheryl Lavender. Welcome Cheryl.

Cheryl Lavender:

Hi oh thanks for this opportunity, everybody.

My name is Cheryl Lavender and I live at 19145 Rivendell Drive in the Shire and uh I'm a retired music teacher.

Is that within the School District of Waukesha boundaries

No it's Waukesha, I'm sorry I forgot Elmbrook or Waukesha okay thank you I'm sorry I forgot to mention that.

President Como: That's okay no problem.

I'm a retired music teacher of 37 years and the recipient of an honorary doctorate degree in music education through the Vandercook School of Music in Chicago. I only say this just to try to earn your trust in the integrity of my comments as the parent of three grown successful children, two engineers and one pharmacist, and the grandparent of eight children um I just want to say that our family has been so grateful having benefited immensely from living in a socially networked neighborhood in the district at the time whose children also attended the same schools as ours. In this environment friendships thrive, parents support one another, carpools transport kids to and from athletic and arts events, clubs, scouts and so much more. Students work on projects together and they become pals in the process. This type of camaraderie nurtures family strength and support. I appeal to this board's global sense to view this petition from a wider lens that focuses on all of our families. No matter which school district our families are from, can we together, as Wisconsin citizens affirm that our common intention is to build strong and supportive learning communities starting with our common foundation, all of our families. I sincerely hope so, the strength of our families makes for stronger communities; the strength of our communities makes for a stronger State of Wisconsin; the strength of our state makes for a stronger United States. 






### 19325 Rivendell Dr., Brookfield, WI 53045; Distance, Home to School

### Horning Middle School (School District of Waukesha): 4.2 miles, 9 min. Drive




### Wisconsin Hills Middle School (Elmbrook Schools): 1.1 miles, 3 min drive



Two potential motions can be considered:

1) Move to approve the resolution granting the reorganization requested in the petition filed on January 13, 2022, and ordering detachment of the territory described in said petition from the School District of Waukesha and attachment of the territory to the School District of

lmbrook.

2) Move to approve the resolution denying the reorganization requested in the petition filed

on January 13, 2022 and dismissing the petition.

**Presentation**: The School District of Elmbrook received notification from the School District of Waukesha that a Petition to Alter School District Boundaries was filed on January 13, 2022. The petitioners, Drs. Max and Kate Krucoff or their representative, may provide additional information regarding their petition.

**Background/Context**: A petition to detach 8 lots and 2 out lots of The Shire Subdivision from the School District of Waukesha and to attach the parcels to the School District of Elmbrook has been filed by Drs. Max and Kate Krucoff. The lots are located in the City of Brookfield.

Chapter 117 of the Wisconsin Statutes provides for different procedures for school district reorganization depending on the nature of the territory being detached/attached. A reorganization involving a "small territory" may be initiated by either the owners of the territory or the school boards to which the territory is to be detached/attached. A territory is defined as small if: 1) The assessed valuation of the territory proposed to be transferred, divided by its assessment ration, is less than 7% of the equalized valuation of the school district from which it is proposed to be detached, and 2) Less than 7% of the enrollment of the school district from which the territory is proposed to be detached resides in the territory proposed to be transferred. The 2021 value of the property is \$9,940,100 and the assessment ratio is

0.922928796. The number of pupils residing in the territory on the most recent 3rd Friday in September or 2nd Friday in January for categories of students to include is 1.

Wis. Stat. 117.15 sets forth criteria by which school boards must evaluate school district reorganization requests. The following items should be considered when assessing the effect of the reorganization on the educational welfare of all the children residing in all of the affected school districts:

- 1. The geographical and topographical characteristics of the affected school districts, including the estimated travel time to and from school for pupils in the school districts.
- 2. The educational needs of all of the children residing in the affected school districts, the educational programs currently offered by each affected school district and the ability and commitment of each school district to meet those needs and continue to offer those educational programs.
- 3. If territory is proposed to be detached from one school district and attached to an adjoining school district, whether the proposed detachment will have any adverse effect on the program currently offered by the school district from which the territory is proposed to be detached, including both curricular and extracurricular aspects of that program.
- 4. The testimony of and written statements filed by the residents of the affected school districts.
- 5. The estimated fiscal effect of the proposed reorganization on the affected school districts, including the effect of the apportionment of assets and liabilities.
- 6. Whether the proposed reorganization will make any part of a school district's territory noncontiguous.
- 7. The socioeconomic level and racial composition of the pupils who reside or will reside in territory proposed to be detached from one school district and attached to an adjoining school district or in a school district proposed to be dissolved; the proportion of the pupils who reside in such territory who are children at risk; and the effect that the pupils described in this paragraph will have on the present and future socioeconomic level and racial composition of the affected school districts and on the proportion of the affected school districts' enrollments that will be children at risk.
- 8. Other appropriate factors.

Per Wis Stats 117.12(3) "Before adopting a resolution under this subsection that grants or denies the reorganization, each school board shall give the electors and owners who signed the petition under sub. (2) an opportunity to meet with the school board to present their reasons for the proposed reorganization. Failure of a school board to adopt a resolution before March 1 either ordering or denying the reorganization constitutes a denial of the reorganization by the school board."

**Budget**: This decision would not directly impact the budget of the district, however, the property value would be added to the overall value of the district and the students residing in the territory would be counted as resident students for revenue limit and state aid purposes if they attended school in the district or if they open enrolled to another public school district.



The petition, file 2022-09, to detach property from the School District of Waukesha and attach it to the Elmbrook School District has been denied. Petitioners whose property detachment requests have been denied have a right to appeal under the provisions of section 117.12(4), Wisconsin statutes.

The law provides that a majority of the electors residing in the territory, or the owners of 50% or more of the territory, may appeal the denial to an appeal panel by filing notice of appeal with the secretary of the School District Boundary Appeal Board <u>before</u> the March 15 following the denial. See s.115.01 (13), Wisconsin statutes, for a definition of electors.

The law further provides that the State Superintendent may charge a filing fee for such appeals. The appeal filing fee is \$750.00 – see <a href="https://dpi.wi.gov/sms/school-district-boundary-appeal-board">https://dpi.wi.gov/sms/school-district-boundary-appeal-board</a> for the fee schedule.
