## ORDER OF SCHOOL DISTRICT REORGANIZATION

Based on Consolidation

WIS. DPI

The Boards of Education of: the School District of Chetek and the Weyerhaeuser Area School District, acting pursuant to the provisions of § 117.17, Wis. Stats., do hereby order that the following school districts be dissolved, to wit: School District of Chetek and the Weyerhaeuser Area School District and that the new school district be created comprising all the territory included in the aforementioned dissolved school districts.

## It is further ordered:

- 1. The name of the new school district will be: Chetek-Weverhaeuser Area School District.
- 2. The type of school district structure will be: <u>Common</u> under § 115.01(3) and will operate under this provision of Chapter 120, Subchapter 1.
- 3. The grades to be taught in the newly created school district will be: <u>Kindergarten through 12<sup>th</sup> grade</u>, under § 115.01(2), Wis. Stats.
- 4. The school board of the newly created school district will be composed of Seven (7) members, under § 120.01, Wis. Stats.
- 5. The terms of school board members and plan of election pursuant to § 120.02, Wis. Stats., shall be as follows:
  - a. The method of election of school board members of the newly created school district will be at large in accordance with § 120.06, Wis. Stats. Five (5) members will come from the current School District of Chetek and two (2) members will come from the current Weyerhaeuser Area School District.
  - b. (1) Those members who seats represent the territory formerly included within the School District of Chetek, consisting of five (5) seats, shall be elected to three, two and one-year terms. In accord with § 120.02(3)(a)3., Wis. Stats., determination of the terms to which the five (5) representatives are elected shall be based upon the number of votes received by candidates for the Chetek seats. The candidate with the highest number of votes shall be awarded one three-year term; the candidate with the second highest number of votes shall be awarded the second three-year term; the candidate with the third highest number of votes shall be awarded the two-year term; the candidate with the fourth highest number of votes shall be awarded one one-year term; and the candidate with the fifth highest number of votes shall be awarded one-year term.
    - Those members who seats represent the territory formerly included within the Weyerhaeuser Area School District, consisting of two (2) seats, shall be elected to three and two-year terms. In accord with § 120.02(3)(a)3., Wis. Stats., determination of the terms to which the two (2) representatives are elected shall be based upon the number of votes received by candidates for the Weyerhaeuser seats. The candidate with the highest number of votes shall be awarded the three-year term; and the candidate with the second highest number of votes shall be awarded the two-year term.
  - c. Commencing with the second election and for each of these seats, each term shall be for a term of three (3) years. Upon completion of the initial terms for each seat in 5.b.(1) and 5.b.(2), those seats will be voted on at large, with the members being elected district-wide, with no requirement that a set number of seats come from the territory formerly included within the School District of Chetek or Weyerhaueser.
  - d. All of the above seats shall be elected by the electors of the consolidated school district as a whole.

- 6. The date of election of the first school board of the newly created school district will be the 6th day of April, 2010.
- 7. The time and place of the first annual meeting, if one is held, of the newly-created district will be 8:00 p.m. on the 27th day of September, 2010, at Chetek-Weyerhaeuser High School IMC in accordance with § 117.17(1), Wis. Stats.
- 8. The effective date of this reorganization will be the 1st day of July, 2010, in accordance with § 117.08(4), Wis. Stats.
