

ESSA School Level Reporting Technical Information

Updated October 3, 2018

File Format Specification

LEAs will be able to upload a comma-separated text values (CSV) file for SLR.

The file format will be the same for both the Budget and Annual SLR collections.

There will be no ability to upload a listing of the Recommended Standard or Optional Exclusions selected for the LEA; those must be entered manually through the application.

Row Definitions	
<i>Row Number</i>	<i>Description</i>
1	Header row, required for upload but ignored by parser.
2	LEA row, includes all data submitted at LEA level. OrgCode is the 4-digit district/LEA code (with leading zeroes) assigned in the DPI School Directory. Values for Exclusions, Federal, and StateLocal are exclusive of expenditure data submitted for the individual schools reported. Value of Enrollment includes data submitted for schools; it may not be less than the total of individual school enrollments reported, but if it is more the LEA will be asked to explain why.
3+	One row per school. Each OrgCode is the 4-digit school code (with leading zeroes) assigned in the DPI School Directory. Values for Exclusions, Federal, and StateLocal are exclusive of expenditure data submitted for the LEA.
